In pursuance of instructions contained in Postal Directorate letter No 17-08/2018-SPN-I dated 15.06.2022, the competent authority has been pleased to declare the result of **Postman and Mail Guard Examination-2023 limited to MTS and GDS** of HP Circle held on 30.04.2023, at venue Govt Girls Senior Secondary School Portmore Shimla, in respect of selection of MTS made from parent and other postal/RMS divisions and selection of GDS from recruiting postal/RMS divisions for the vacancy year 2023.

2. As per Directorate letter No 17-08/2018-SPN-I dated 15.06.2022, regarding procedure for selection of the candidate based on single examination for the post of MTS/Postman/Mail Guard, procedure prescribed in para 2B(Stage-I) to para 2 H. Stage VII is meant for declaration of result in respect of qualified MTS candidates in Postman/Mailguard Examination. Since there is no qualified candidate available in any postal/RMS division from MTS cadre, hence the procedure mentioned in above stages of ibid mentioned letter has been dispensed with. Hence, the present selection has been made from qualified GDS candidates of the recruiting postal/RMS division as per procedure prescribed in para 2I. Stage VIII and 2J Stage IX of the ibid mentioned letter for postal Directorate vacancies of Postman/Mailguard examination 2023.
3. As on date of declaration of result, the candidates have been allotted from recruiting postal/RMS units only against the notified vacancies. The summary of the vacancies filled and unfilled is appended as **Annexure-II** to this Memo. The candidates who obtained minimum qualifying marks as per Dte Letter No 17-08/2018-SPB-I dated 10-05-2019 & 17-08/2018-SPB-I dated 26-06-2019, 17-08/2018-SPN-I dated 05-04-2022 and SOP issued by Dte vide letter No-A-34012/02/2022-DE dated-11-08-2022 were marked qualified and the remaining as not qualified combined in (Paper-I plus Paper-II) and Paper-III respectively.;

4. The qualifying criteria for Paper-III i.e. DEST (Data Entry & Skill Test) in r/o aforesaid examination as mentioned in Directorate letter no. 17-08/2018-SPN-I dated 19.12.2022 is as under:-

5. The division wise list of the successful selected meritorious candidates is appended as **Annexure-I** to this Memo.
6. (i) One vacancy of PH (HH) in Postman cadre of Mandi Division has not been filled up due to non availability of qualified candidate with benchmark disability and will be filled up as per Recruitment Rules from open market as no eligible candidate is available in any Division in the circle.
- (ii) Similarly, one vacancy of PH (VH-LV) in Postman cadre of Shimla Division could not be filled up due to non availability of eligible PwD candidate of notified category and action may be taken to fill up the post as per Recruitment Rules from open market as no eligible candidate is available in any Division in the circle.
- (iii) One vacancy of ST category in Hamirpur division has not been recommended to be filled up due to non availability of qualified GDS candidate in the parent recruiting unit. The same will be filled up from the surplus qualified candidates of other postal divisions.
7. While declaring the result, in case of bunching *inter se* rank/ merit has been decided as per seniority in lower cadre for MTS and as per date of birth for GDS candidates.
8. In case subsequently if it is found that any of the qualified/selected candidate was not eligible to appear in the examination under the extant rules or instructions on the subject or for any other reasons or in case any mistake is found with regard to announcement of the result of any candidates for any reason whatsoever his her name will be deleted from the list of successful candidates as the case may be. The result is also subject to any change in merit list of the selected candidate due to any unforeseen reason in accordance with the extant rules on the subject. The present result is further subject to outcome of court/ CAT cases, correction of clerical mistakes, if any. The candidature/ selection of the selected candidates is liable to be cancelled, if later on it is found that the false information has been given by the candidates or candidate was not eligible due to any disciplinary/ criminal case against him/ her or otherwise. The result has been prepared on the basis of information furnished by the candidates and further verified by the Divisional/Units Heads. The concerned Divisional/ Unit Heads are requested to carry out all required pre-appointment formalities as per prevalent Rules and instructions issued from time



to time. Before appointment, it should be ensured that no disciplinary/Criminal case is pending/ contemplated or no penalty is current against the selected/ promoted candidates.

9. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules and the verification of genuineness of various mandatory certificates of the candidates by the concerned Head of unit.
10. As per instructions contained in Postal Directorate letter 17-08/2018-SPN-I dated 15.06.2022, the orders of the recruitment or promotion to be issued by the head of the units in respect of all the selected candidates should clearly mention that if the official does not join the new assignment within seven (7) days it will be deemed to have been refused. The official on leave may be allowed to join even after 7 days if they communicate in writing to accept the promotion in that case the official will be allowed to join after expiry of approved leave period.
11. All Head of Units of selected candidates are instructed to take immediate necessary action for joining of newly selected candidates as per extant provisions. The Divisional Heads are requested not to send separate letter of carrying out joining process / appointment letters to Circle Office. The joining process should be completed on or before 31.07.2023. The joining report shall be submitted in a consolidated manner to this section by 01.08.2023 positively.
12. This issues with the approval of competent authority.
