- 1.1 The candidate has also been declared successful for the post of Postman in Faridabad Division vide this office memo of even number dated 27.06.2023. The candidate concerned may submit his willingness to this office whether he wants to join in Postman or MTS cadre.
- 1.2 The candidates could not qualify Paper IV (i.e. DEST). Hence, were not eligible for Postman Cadre but have been considered for MTS Cadre.
- 2. The names of the candidates have been arranged in the order of merit. If however, there is any mistake in the name/Roll Number/community of the candidate is noticed the same may be corrected and intimated to this office immediately. The candidates who obtained same marks, Divisional Heads are requested to decide their seniority at their end as per rule.
- 3. Before issuance of appointment orders to the selected candidates, all Divisional Heads should match the photograph of the candidate allowed to appear in the examination with the videography clips recorded during the examination. CD/DVD of Paper-I, II & III containing videography of said examination will be supplied to all the Divisional Heads by SSPOs Ambala.
- 4. The Divisional Heads before promotion of the official should ensure that no vigilance/disciplinary case is either pending or contemplated against him/her and no punishment like stoppage of increment is current against the official. In case there is any such case, the official concerned may not be promoted and the facts be reported to this office immediately.
- 5. The eligibility of the candidates to take the examination has been decided on the basis of the information furnished by the Divisional Heads while forwarding their applications for this examination. Therefore, all the Divisional Heads are requested to check up the eligibility of the candidates before going ahead. If it is later on found that any of the selected candidate was not eligible to take the examination under the existing rules or instructions on the subject or for any other reason whatsoever, his/her name will be deleted from the list of successful candidates or list of candidates securing concession as the case may be.
- 6. All the Divisional Heads are directed to finalize the candidature of candidates who were allowed to appear in said examination on **PROVISIONAL BASIS** and furnish the report to this office by <u>31.08.2023</u>.
- 7. <u>In case, any candidate is not willing for promotion to the MTS Cadre, then her/his unwillingness duly signed by him/her, verified and countersigned by the Divisional Head should be submitted to this office by **31.08.2023**. If no unwillingness is received from any candidate within stipulated time, he/she will be deemed relieved.</u>
- 8. The result in respect of candidates allotted to their parent Division/Unit in MTS Cadre issued vide this office letter of even number dated 27.06.2023 stands unchanged.
- Request for change of Division/Unit allotted shall not be entertained in any case or under any circumstances.

10. All the Divisions/Units shall issue posting orders by 28.08.2023 and ensure relief of candidates by 01.09.2023. Original Applications Forms/Personal Files in respect of the candidates that have been re-allotted to some other Division/Unit may be sent to the concerned Division/Unit.
