- iii. In case, at any time, it is detected that the candidates so selected had applied and appeared the examination with false declaration of data, his/her selection will be cancelled without any notice.
- iv. All the Heads of units of selected candidates should be instructed to take necessary action for joining of newly selected candidates as per provisions. The Divisional/Unit heads are requested not to send separate letter of carrying out joining process/appointment letters to Circle Office. The joining process to be completed on or before 13.09.2023 and joining orders to be issued to all on 06.09.2023. A consolidated report should be submitted to this office on 15.09.2023 without fail. In Case the candidate does not join the recruited post within 7 days it will be deemed to have been refused and next candidates will be considered.
