In pursuance of instructions contained in Postal Directorate letter No 17-08/2018-SPN-I dated 15.06.2022, the competent authority has been pleased to declare the result of **Multi Tasking Staff (MTS) cadre** of HP Circle held on 30.04.2023, at venue Govt. Girls Senior Secondary School Portmore Shimla, in respect of selection of GDS from recruiting Postal/RMS divisions for the vacancy year 2023.

- 2. As per Directorate letter No 17-08/2018-SPN-I dated 15.06.2022, regarding procedure for selection of the candidate based on single examination for the post of MTS/Postman/Mail Guard, the present selections have been made and result declared from qualified GDS candidates of the recruiting division as per procedure prescribed in para 2 (L) stage X(A).
- 3. As on date of declaration of result, the candidates have been allotted from recruiting postal/RMS units only against the notified vacancies. The summary of the vacancies filled and unfilled is appended as Annexure-II to this Memo. The candidates who obtained minimum qualifying marks in Paper-I and Paper-III separately, as per Dte Letter No 17-08/2018-SPB-I dated 10-05-2019 & 17-08/2018-SPB-I dated 26-06-2019, 17-08/2018-SPN-I dated 05-04-2022 and SOP issued by Dte vide letter No-A-34012/02/2022-DE dated-11-08-2022 were treated as qualified and the remaining as not qualified.

- 5. In case of refusal by any candidate selected from the recruiting divisions, the process for giving selection to next meritorious qualified candidate(s) of that division will continue till all qualified candidates of a particular category according to available vacancies are exhausted.

- 6. (i) One vacancy earmarked for PH (VH) category in MTS cadre of Mandi Division could not be filled up due to non availability of qualified candidate with benchmark disability and will be filled up as per Recruitment Rules.
 - (ii) Similarly, one vacancy of PH (OH) in MTS cadre in RMS HP Division Mandi could not be filled up due to non availability of eligible PwD candidate of earmarked category and action will be taken to fill up the post as per Recruitment Rules.
 - (iii) One vacancy each of EWS and OBC categories in RMS HP Division Mandi remained unfilled due to non availability of qualified GDS candidate in the parent recruiting unit.
- 7. All the above unfilled vacancies will be filled up from the surplus qualified candidates of other postal /RMS divisions as per instructions issued by Dte vide letter No 17-08/2018-SPN-I dated 15.06.2022. Also the vacancies of MTS cadre for the year 2023 in respect of DAP Sundernagar and Circle Office shall be filled up from surplus qualified candidates of all division after completion of process of joining of the successful candidates from parent recruiting divisions.
- 8. While declaring the result, in case of bunching *inter se* rank/ merit has been decided as per date of birth for GDS candidates.
- 9. Since the successful candidates are being inducted as regular departmental employees for the first time, all the appointing authorities must verify the SC/ST/OBC/EWS and educational certificates afresh from the issuing authorities.
- 10. In case, subsequently it is found that any of the qualified/selected candidate was not eligible to appear in the examination under the extant rules or instructions on the subject or for any other reasons or in case any mistake is found with regard to announcement of the result of any candidates for any reason whatsoever his her name will be deleted from the list of successful candidates as the case may be. The result is also subject to any change in merit list of the selected candidate due to any unforeseen reason in accordance with the extant rules on the subject. The present result is further subject to outcome of court/ CAT cases, correction of clerical mistakes, if any. The candidature/ selection of the selected candidates is liable to be cancelled, if later on it is found that the false information has been given by the candidates or candidate was not eligible due to any disciplinary/ criminal case against him/ her or otherwise. The result has been prepared on the basis of information furnished by the candidates and further verified by the Divisional/Units Heads. The concerned Divisional/ Unit Heads are requested to carry out all required pre-appointment formalities as per prevalent Rules and instructions issued from time to time. Before appointment, it should be ensured that no disciplinary/Criminal case is pending/ contemplated or no penalty is current against the selected/ promoted candidates.
- 11. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules and the verification of genuineness of various mandatory certificates of the candidates by the concerned Head of unit.

- 12. Before issue of orders of recruitment/appointment all the Divisional Heads are requested to confirm that the selected candidate(s) were working in the same division on 01.01.2023 and was eligible to be considered for the vacancies of MTS cadre of that division. In case any discrepancy is observed the appointment orders of all the selected candidates should be withheld and matter should be reported to Circle Office immediately.
- 13. As per instructions contained in Postal Directorate letter 17-08/2018-SPN-I dated 15.06.2022, the orders of the recruitment or promotion to be issued by the head of the units in respect of all the selected candidates should clearly mention that if the official does not join the new assignment within seven (7) days it will be deemed to have been refused. The official on leave may be allowed to join even after 7 days if they communicate in writing to accept the promotion in that case the official will be allowed to join after expiry of approved leave period.
- 14. All Head of Units of selected candidates are instructed to take immediate necessary action for joining of newly selected candidates as per extant provisions. The Divisional Heads are requested not to send separate letter of carrying out joining process / appointment letters to Circle Office. The joining process should be completed on or before 08.09.2023. The joining report shall be submitted in a consolidated manner to this section by 11.09.2023 positively.
