The competent authority is pleased to declare the 2<sup>nd</sup> surplus list for Mail Guard and 1<sup>st</sup> surplus list for MTS from eligible GDS through Competitive Examination for recruitment to the cadre of Postman, Mail Guard and MTS for the vacancy year 2022 held on 04.09.2022.

2. The list of candidates declared successful for the post of Mail Guard is enclosed as **Annexure-A** and list of candidates declared successful for the posts of MTS is enclosed as **Annexure-B**.

3. The candidates have been selected only if the post of Mail Guard/MTS has been opted for by the candidates subject to fulfilling eligibility conditions as per the guidelines issued vide Postal Directorate memo No. 17-08/2018-SPN-I dated 15.06.2022.

4. Merit list of Mail Guard has been prepared as per combined marks obtained in Paper-I & II and also subject to their qualifying in paper-III and Paper-IV [DEST].

5. Merit list of MTS has been prepared as per marks obtained in Paper-I and also subject to their qualifying in paper-III. Rank/Merit of candidates scoring same marks in Paper-I, has been decided as per instructions contained in Postal Directorate letter no. 04-08/2019-SPN-I dated 11/12/2020.

6. The selection of the candidates is purely provisional subject to fulfilling of required conditions of relevant Recruitment Rules & verification of genuineness of various mandatory certificates of the candidates by the concerned head of Division/unit.

7. It is the personal responsibility of the Appointing Authorities to carry out verification of valid documents i.e. Date of Birth poof, educational qualification certificates, category (SC/ST/OBC/EWS) certificates and other eligibility conditions for respective vacancy year, as per ruling on the subject before issuing provisional appointment orders to the selected candidates.

8. In case, at any time, if it is detected that the candidate so selected had applied and appeared the examination with false declaration relating to educational qualification, category, length of service and physical disability etc. his/her selection will be cancelled without any notice.

9. In case, if it is found subsequently that any of the promoted/selected candidates(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case of any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidates due to any unforeseen reasons.

10. The appointing authorities are requested to carry out all the required pre-appointment formalities as provided in relevant rules and instructions issued from time-to-time on the subject as applicable. In case, there is any mistake in the Name, Roll No, Category etc. of the candidates then the same may be corrected and intimated to this office immediately.


