
The Competent Authority has been pleased to approve declaration of surplus result pertaining to Limited Competitive Examination (LCE) for recruitment to the cadre of MTS from the eligible Gramin Dak Sevak (GDSs) for the vacancy year 2023 (01.01.2023 to 31.12.2023) for which the written examination in Paper I, II & III was held on 30.04.2023 followed by DEST on 03.12.2023 in accordance with the Directorate instructions contained in Letter No.17-08/2018-SPN-I dated 05.04.2022.

2. The Provisional and Final Answer Keys (Series A, B, C & D) of Paper-I, Paper-II and Paper-III of the above LDCE/Competitive Examination held in Odisha Circle were already circulated to all Unit/Divisional Heads as well as displayed in Odisha Post Website.

3. In pursuance of Directorate instructions contained in Letter No.17-08/2018-SPN-I dated 05.04.2022, the candidates who qualified in both Paper-I and Paper-III (Separately), shall be considered for final selection. Accordingly, the Merit List has been prepared only on the basis of marks secured in Paper-I only, since Paper-III is qualifying in nature. The result has been compiled taking the scores of Paper-I as merit and also in accordance with the procedure prescribed vide Directorate Letter No.17-08/2018-SPN-I dated 15.06.2022.

The qualifying marks for selection to the cadre of MTS as per Directorate letter No.17-08/2018-SPN-I dated 05.04.2022 is as hereunder.

5. The selection of candidates in Annexure-II is purely provisional and subject to fulfilment of conditions of relevant recruitment rules for promotion/appointment to the cadre of MTS as per directorate instruction contained vide letter no X-7/6-2022-SPN-II dated 17.05.2023.

6. Divisions/Units are requested to verify the relevant particulars of the selected candidates on their own level, before issue of appointment orders. In case, it is subsequently found that any of the selected candidate(s) was not eligible to take the examination under the extant rules or instructions on the subject for any other reasons or in case any mistake is found with regard to announcement of result of any candidate for any reason whatsoever, the same may be brought to the notice of Circle Office, Bhubaneswar immediately, so that his/her name could be deleted from the list of successful candidates. This should be incorporated in the promotion/ appointment letters issued.

7. Before appointment, it should be ensured that no disciplinary/vigilance case is pending or contemplated or punishment is in force against the successful/selected/allotted candidates. If, any such case exists, the same should be referred to Circle Office, Bhubaneswar immediately.

8. Before issuing appointment orders Directorate letter No.W-17/10/2023-SPN-I-DOP dated 06.03.2023, regarding guidelines on eligibility to appear LDCE after refusal of earlier offer of promotion may kindly be referred to.

9. In Directorate letter No.04-08/2019-SPN-I dated 11.12.2020, detailed guidelines on deciding of inter-se rank/merit in case of more than one candidate scoring equal mark in departmental examination/DR recruitment examination have been issued.

10. The candidates of reserved category i.e. SC/ST who are shown as qualified on merit and selected against UR vacancies should be adjusted against UR vacancies in the Roster.

11. Provisional Candidates: The Heads of the concerned Divisions/Units are requested to immediately finalise the provisional candidature and such cases should not be kept pending for long time, so that the provisional candidates may not have to wait for the result inordinately. If name of any provisionally permitted candidate is found in the list of selected candidates, the same may be brought to the notice of Circle Office, Bhubaneswar for immediate necessary action. It is informed that the names of the candidates have been arranged in the order of merit. In respect of candidates who got equal marks in the total, Divisions/Units are requested to arrange their position in the merit list according to their inter se seniority/instructions on the subject and intimate the same to Recruitment Section of the Circle Office, Bhubaneswar. It may also be ensured that no provisional candidate, even if found in the list of selected candidates, shall be given promotion/appointment under any circumstances without regularization of his/her candidature.

12. The Heads of Divisions/Units should ensure timely issue of offer of appointment letters to the successful candidates so that the selected candidates/officials join in their respective offices of posting at the earliest as per extant rules,

13. The Unit/Divisional Heads are requested to issue promotion/appointment of selected candidates on or before 08.07.2024 (positively clearly indicating that if the official does not join the promotional post within seven (07) days it will be deemed to have been refused. Official on leave may be allowed to join even after seven days if they communicate in writing to accept the promotion and in that case the official will be allowed after expiry of approved leave period. Controlling Officers are advised to contact such successful candidates who are on leave for obtaining their consent to join promotional post in writing. Similarly, candidates who do not wish to join promotional posts may be encouraged to communicate the same in writing.
