As per RR Amendment Rules 2023 (Annexure III-A in notification) para 2 (a) IV., following MTS are eligible for promotion on the basis of LDCE-

(ii) Multi Tasking Staff in level-1 of the pay matrix with total regular service of five years including service rendered regularly as Gramin Dak Sevaks as on the 1st day of January of the year to which the vacancy belongs to or as per the guidelines issued by the Central Government from time to time.

However, it is observed that in application form enclosed with notification, the same point is not available. Hence, new application form for such MTS candidates only is attached herewith. The same may be brought to the notice of all such MTS candidates and ensure that the details of date of engagement in GDS and total eligible service as GDS are filled properly by the concerned MTS.
