
**Sub: Limited Departmental Competitive Examination (LDCE) for Promotion to the posts of PA/SA for the vacancy year 2024 held on 21.07.2024 followed by the DEST on 09.08.2024- Declaration of Final result**

Reference is invited to this office letter of even no. dated 05.08.2024 whereby the result of Paper-I of above said examination was declared. The Data Entry Skill Test (DEST) for the candidates who qualified in Paper-I was held on 09.08.2024. Based on the result of DEST, the Competent Authority has directed the undersigned to declare the final result of above said examination.

2. In pursuance of Directorate instructions contained in Letter No. 17-08/2018-SPB-I dated 10.05.2019, the candidates who qualify in Paper-I & DEST separately shall be considered for final selection and their Merit shall be drawn in the order of marks secured in Paper-I as DEST is qualifying in nature. Also, as per the Recruitment Rules 2022 of PA/SA cadre, notified in GSR 459 (E) dated 17.06.2022, communicated vide Directorate Lr. No. 04-05/2015-SPN-I dated 20.06.2022, and Directorate's instructions in Letter No. X-12/6/2021-SPN-II dated 31.12.2021, a single merit list at Circle Level is prepared and the selected candidates have been allotted to the Divisions/Units as per merit (category wise, i.e., UR, SC & ST) vis a vis order of preference exercised by the candidates subject to availability of vacancies in the Division/Unit.

3. Since the above LDCE/Competitive Examination is meant for recruitment of vacancies under departmental promotion quota, no reservation for OBC, EWS categories is applicable as per the extant rules/guidelines on the subject.

4. Offer of appointment/promotion will be given by concerned Divisions/Units to selected candidates by 17.08.2024 to either accept or refuse the offer by 19.08.2024 by 1200 hrs. If a candidate does not give his acceptance or refusal to join the offered post within the stipulated time, it shall be deemed to have been accepted. However, if such a candidate is already selected/appointed for/in higher post, doesn't give his acceptance, it shall be deemed to have been refused. These provisions of 'deemed acceptance' and 'deemed refusal' should be communicated to the candidate.

5. In case of deciding of inter-se rank/merit in case of more than one candidates scoring equal marks, instructions contained in Directorate's letter No. 04-08/2019-SPN-I dated 11.12.2020 has been followed and accordingly Inter-se rank/merit has been decided for all categories.
6. The information relating to the Names of the candidates, their Roll numbers and Community have been shown on the basis of information furnished by the Heads of Division/Units. The Head of the Divisions/Units are requested that particulars of Successful candidates, viz. Roll numbers, names, community and their eligibility to appear in the said examination, are re-checked before issuing offer of appointment. If any discrepancy has been found the same may be corrected and the matter should be reported to this office. They will also check that number of such candidates allotted to their Units is not more than the number of vacancies proposed to be filled through the said examinations.
7. In case, if it is found subsequently that any of the selected candidate(s) was not eligible to appear in the examination under the existing Rules/Instructions on the subject or for any reasons or in case any discrepancy is found with regard to announcement of Result of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be.
8. In respect of SC/ST candidates, "promotion of the candidates is provisional subject to verification of their caste status. Head of the Unit will take an undertaking from the officials to this effect at the time of their relieving and ensure verification of caste status within one month".
9. Any discrepancy found in respect of any item, the matter should immediately be reported to this office.
10. This result is also subject to any change in merit list of selected candidates for any reason in accordance with the existing Rules and Instructions on the subject. It may be ensured that no Provisional candidate is given appointment without regularization of the candidature and such cases need not to be kept pending except in very exceptional & unavoidable circumstances.
11. No GDS candidate is selected in GDS to PA/SA Examination for the year 2024.
12. SSPOs, New Delhi Central Division is requested to keep 01- UR vacancy reserve for the provisionally allowed candidate appeared in said examination.
13. Requests for revaluation will not be entertained in the light of instructions of the Directorate.
