The Competent Authority is pleased to declare the results of the Limited Departmental Competitive Examination (LDCE) for promotion to the posts of Postal Assistant (Circle Office), Postal Assistant (Post Office) and Sorting Assistant (Railway Mail Service) from eligible officials of Category A, Category B and Competitive Examination from eligible GDS candidates for the vacancy year 2024 (01-01-2024 to 31-12-2024) held on 21-07-2024 and DEST held on 11-08-2024.

2. The provisional and final answer keys were displayed in the departmental website by Himachal Pradesh Circle. The evaluation of Paper-I has been done for 97 questions awarded one mark each. The minimum qualifying marks in Paper-I and Data Entry and skill Test (DEST) as per Dte Letter No 17-08/2018-SPB-I dated 10.05.2019, 17-08/2018-SPB-I dated 26-06-2019, 17-08/2018-SPN-I dated 09-09-2021 & 17-08/2018-SPN-I dated 19.12.2022 and SOP issued by Dte. vide letter No-A-34012/02/2022-DE dated-11-08-2022 are as under for each community / paper:-

- 3. Since this is a promotional examination and no reservation in promotion for OBC and EWS candidates, hence, the minimum qualifying percentage of UR category will be applicable for them.
- 4. As on date of declaration of result, the candidates have been allotted against the declared vacancy. The detail of final vacancy position notified vide this office Memo No R&E/77-7/2024 dated 14.08.2024 under PA (CO), PA (PO) and SA cadres is appended as Annexure-I to this memo.
- 5. The LDCE results are declared based on the Department of Posts (Postal Assistant & Sorting Assistant) Recruitment Rules, 2022 issued by Directorate vide F. No. 04-05/2015-SPN-I dated 20-06-2022 & as amended from time to time, SOP vide letter no. A-34012/02/22-DE dated 11-08-2022 and Notification issued by this office vide letter no. R&E/77-8/2024 dated 11-06-2024.
- 6. In pursuance to instructions contained in Directorate letter No.X-12/6/2021-SPN-II dated 31-12-2021, selection of candidates through examination has been done by preparing a single merit list at Circle Level. The procedure for selection of candidates for the post of PA/SA

on the basis of LDCE as envisaged by Directorate vide letter no. W-04/8/2022-SPN-I dated 26-10-2023 has been followed for allotment of successful candidates. The selected candidates have been allotted to the divisions/units as per merit (category wise, UR, SC & ST, PwBD) vis-à-vis order of preference exercised by the candidates subject to availability of vacancies in the respective Division/Unit and as per their turn of allotment.

- 7. Candidates in this merit list who have joined the Division / Unit allotted to them will not be eligible for re-consideration for re-allotment to other Divisions/Units (which were their top preferences and could not be allotted due to non-availability of vacancies on their turn) in which vacancies may arise due to declinations and these declination vacancies will be allotted to the next meritorious candidates.
- 8. The results containing list of the successful candidates of Category A, Category B (arranged in the Circle-wise merit order) and from GDS is shown in <u>Annexure II</u>. The *inter se Rank / merit* of candidates have been decided as per Directorate's letter No.04-08/2009-SPN-I dated 11-12-2020. Consequent to this, if there is change in the merit list, the same may be communicated to this office for issuing correction. The result is also available in the Departmental website (<u>www.indiapost.gov.in</u>).
- 9. Candidates have been allotted to the extent of vacancies notified for vacancy year 2024 except 02 PwBD horizontal vacancies viz., 01 "HH" and 01 Other Category under PA(PO) Cadre due to non-availability of qualified PwBD Candidates in the merit list. The said vacancies have been carried forward to the next vacancy year 2025 as per extant guidelines contained in DoP&T letter no. 36012/1/2020-Estt(Res-II) dated 17-05--2022 and Postal Directorate letter no. SC-12/9/2022-SCT.DoP dated 14.09.2022.
- 10. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Heads of Division/Unit. In case there are any mistakes in the details of candidate(s), the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever, his/her name will be removed from the list of selected candidates, as the case may be.
- 11. In accordance to instructions contained in Directorate's F No.W-17/10/2023-SPN-I-DOP dated 06-03-2023, the candidates who were declared successful through LDCE for promotion to PA/SA Cadre and had declined their promotion for vacancy year 2023 and have again been declared successful through LDCE for promotion to PA/SA Cadre for vacancy year 2024 should be promoted only after completion of their embargo period.
- 12. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Divisions/Units are requested to verify the current status of the candidature of the qualified candidates before promoting the official. The official/candidate against whom vigilance or disciplinary case is pending or those undergoing punishment should not be promoted and such cases should be



referred back to this office as per Directorate's letter no. X-7/6/2022-SPN-II dated 17-05-2023 and amended from time to time.

- 13. All the Divisions / Units should issue promotion and allotment order to the successful candidates of Annexure II by17-08-2024. The successful candidates may be directed to accept / decline their place of posting on promotion by 20th August 2024 in the proforma attached, failing which, their promotion will be deemed declined.
- 14. All the Heads of Divisions / Units of selected candidates should be instructed to take immediate necessary action for joining of newly selected candidates. The Divisional/Unit heads are requested not to send separate letter of carrying out joining process/appointment letters to Circle Office. The joining process to be completed on or before 20-08-2024.
- 15. Final answer Keys {A, B, C & D series} of the above said exam are already uploaded in the Departmental websites www.indiapost.gov.in. This information need not be sought under RTI.
