3. 15 ST backlog vacancies and 2 ST vacancies for the current year remained unfilled due to non availability of eligible candidates in respective category. Divisional Heads concerned are requested to take action against these vacancies as per the instructions on the subject.

3.1 One vacancy in UR (HH) category in PACO cadre and one vacancy in UR (VH) category in PAPO cadre remained unfilled due to non availability of suitable candidates. Accordingly, the vacancies shall be carry-forwarded to the next year as backlog PH vacancy. Further, the carry-forwarded reservation for 2 VH in PAPO cadre and 1 HH in SA cadre shall lapse as the same has already been carry-forwarded for two subsequent years but could not be filled.

4. The names of the candidates have been arranged in the order of community-wise merit. If however, there is any mistake in the name/Roll Number/community of the candidate is noticed the same may be corrected and intimated to this office immediately. The candidates who obtained same marks, Divisional Heads are requested to decide their seniority at their end as per the instructions.


5. Before issuance of appointment orders to the selected candidates, all Divisional Heads should match the photograph of the candidate allowed to appear in the examination with the videography clips recorded during the examination. CD/DVD of Paper-I containing videography of said examination will be supplied to all the Divisional Heads by SSPOs Ambala.

6. The Divisional Heads before promotion of the official should ensure that no vigilance/disciplinary case is either pending or contemplated against him/her and no punishment like stoppage of increment is current against the official. In case there is any such case, the official concerned may not be promoted and the facts be reported to this office immediately.

7. The eligibility of the candidates to take the examination has been decided on the basis of the information furnished by the Divisional Heads while forwarding their applications for this examination. Therefore, all the Divisional Heads are requested to check up the eligibility of the candidates before going ahead. If it is later on found that any of the selected candidate was not eligible to take the examination under the existing rules or instructions on the subject or for any other reason whatsoever, his/her name will be deleted from the list of successful candidates or list of candidates securing concession as the case may be.

8. As per the instructions of the Postal Directorate, Promotion Order/Offer of Appointment to successful candidates must be issued by **17.08.2024**.

9. In case, any candidate is not willing for promotion to the cadre of PA/SA, then his unwillingness duly signed by him/her, verified and countersigned by the Divisional Head should be submitted to this office by **19.08.2024**.
