Note: In case, it is subsequently found that any of the selected candidate(s) was not eligible to take the examination under the extant rules or instructions on the subject or for any other reasons or in case any mistake is found with regard to announcement of result of any candidate

for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be, without any notice. This should be incorporated in the promotion/appointment letters issued.

2. As per Recruitment Rules 2022 PA SA Cadres notified in GST 459(E) dated 17.06.2022 communicated vide Dte letter no. 04-05/2015-SPN-I dated 20.06.2022 and in pursuance of Dte letter no. X-12/6/2021-SPN-II dated 31.12.2021 a single merit list has been prepared at circle level with the successful candidates of the above LDCE/CE examinations.

3. Merit list of the selected candidates has been prepared as per their marks obtained in Paper I and also subject to their qualifying in DEST.

4. The selection of candidates is subject to fulfillment of conditions mentioned in Notification of examinations and relevant Recruitment Rules amended from time to time. There will be no re-allocation.

5. It is the personal responsibility of the Appointing Authorities to carry out verification of valid documents i.e. Date of Birth proof, educational qualification certificates, PWD certificate, respective Category Certificate, Category Validity Certificates etc. and other eligibility conditions for respective vacancy year, as per ruling on the subject before issuing provisional appointment orders to the selected candidates.

6. In case, at anytime, if it is detected that the candidate so selected had applied and appeared the examination with false declaration relating to Educational qualification, category, length of service and physical disability etc., his/her selection will be cancelled without any notice.

7. If it is later noticed that the permission granted to any candidate to appear for the examination was not valid due to one or the other reasons, as per the orders on the subject, the candidature will be cancelled without any notice and his/her name will be removed from the list of successful candidates at any stage.

8. The Divisional Heads should ensure issuance of offer of appointment letter to the successful candidates within 2 days from the date of declaration of result, so that the selected candidates/officials may join in their respective office of posting at the earliest as per extant rules.

9. The Appointing Authorities are requested to carry out all the required pre-appointment formalities as provided in relevant rules and instruction issued from time to time on the subject Also the Divisional/Unit Heads are requested to re-check the pre-requisite conditions prescribed for candidates, with reference to their recommendations made while forwarding the application forms.

10. Before appointment, it should be ensured that, no disciplinary/ vigilance case is pending or contemplated or punishment is current against the selected/ allotted candidates. If any, such case should be referred to this office immediately.



11. The Name, Category and other details of the candidates have been shown as furnished by the concerned Region/Division/Unit. However, if any mistake in the Name/Roll No./Category etc. is noticed, the same may be confirmed with Parent Division of the candidate.

12. It may be ensured that no provisionally permitted candidate is given appointment without regularization of his/her candidature. The Divisions/Units are requested to verify the current status of the candidate of the qualified candidates before appointment.

13. Since there is no reservation for OBC & EWS category in Departmental quota and unfilled vacancies of Departmental quota are being offered to GDS, the candidate belongs to OBC & EWS who fulfills required eligibility criteria of UR category are selected against UR with remark as selected as UR based on their Merit position.

14. As regards to Departmental APS candidates, it may be ensured by the APS authorities that the APS candidates on their discharge from APS are appointed in the Unit/Division shown in the respective Annexure after completing pre-appointment formalities such as verification of caste and imparting training. The Division/Unit heads will please issue NBR certificate with effect from the date of his junior is appointed in PA/SA cadre. All other instructions on the subject issued from time to time may kindly follow.


15. Results of provisionally recommended candidates who have minor punishments is declared as per Dte letter X-7/6/2022-SPN-II dated 17.05.2023, 22.09.2023 and 04.03.2024 and offer of Appointment to such candidates is to be issued after completion of the punishment. Candidates who have major punishment (or punishment is yet to be decided) are kept in sealed cover. The Divisional/Unit heads are requested to finalize the candidature of provisionally recommended candidates and then give offer of Appointment.

16. Also the result of candidates with issues of caste validity certificate/ No regular GDS Appointment order etc are not available, are declared herewith. It is requested to obtain the certificates and issue offer of appointment accordingly.

17. Divisional heads are requested before issuing offer of appointment to check whether any official had refused offer of promotion. In such case offer of promotion is to be issued not before completion of one year from the date of refusal of earlier offer of promotion as per Dte letter no. W-17/10/2023-SPN-I-DOP dated 06.03.2023.

18. Regional APMG/AD will personally monitor the activities and issue offer of Promotion order / offer of appointment by 16.08.2024 and will arrange to submit information of unfilled vacancies to this office by 21.08.2024.
