Subject: Limited Departmental Competitive Examination (LDCE) for promotion to the posts of Postman and Mail Guard from eligible MTS for the vacancy year 2024, held on 25.08.2024 (Sunday) and DEST on 17.09.2024 (Tuesday) of Bihar Circle- Publication of list of successful MTS candidates (Merit list) for the post of Postman and Mail Guard cadre.

In pursuance of Postal Directorate, New Delhi letter no. A-34012/03/2024-DE dated 10.07.2024 and Circle Office, Patna letter no. R&E-83/PM-MG/MTS/Exam/2024 dated 15.07.2024, the notification for LDCE for promotion to the cadre of Postman/Mail Guard from eligible MTS was issued on 15.07.2024. In the said notification it was announced to conduct the above examination for the vacancy year 2024 on 25.08.2024 (Sunday). Accordingly examination of Paper – I, II & III were conducted on 25.08.2024 (Sunday) and Data Entry Skill Test (DEST) Paper – IV on 17.09.2024 (Tuesday).

Now, the results has been prepared as per guidelines of Postal Directorate issued vide letter no.17-08/2018-SPN-I dated 05.04.2022 circulated vide this office email dated 06.04.2022 (06.06 PM), 17-08/2018-SPN\_I dated 18.10.2023 and Postal Directorate letter No. 03-03/2019-SPN-I (Pt-I) dated 17.05.2022 and 04.08.2022.

- 2. On successful completion of aforesaid examination, provisional answer keys of Paper I, II & III (MCQ in series A,B,C & D of all three papers) inviting feedback/challenges from candidates were uploaded on indiapost website on 25.08.2024 On receipt of responses from candidates and recommendation of moderation committee (2) two question in Paper-I and (01) one question in Paper-II have been deleted. Due to deletion of two questions in Paper-I and one question in Paper-II, minimum qualifying marks have been reduced as per para No. 17 of SOP circulated vide Postal Directorate letter No. A-34012/02/2022-DE dated 11.08.2022 and communicated to all concerned vide this office letter No. R& E/SOP/2022 dated 16.08.2022 and based on recommendation/comments received from question setter on report of moderation committee , answer keys for paper I, II & III have been finalized. The same were uploaded on India Post Website on 10.09.2024
- 3. In pursuance of Postal Directorate, New Delhi letter No 17-08/2018-SPN-I dated 05.04.2022, selection has been made strictly on merit based on marks secured in Paper I and Paper II (Combined i.e total of marks secured in Paper I and Paper II). Also secured in minimum qualifying marks in Paper III (Local Language) and Paper-IV (DEST).

## <u>Instructions</u>

- 1. In case, it is subsequently found that any of the selected candidate(s) was not eligible to take the examination under the extant rules or instructions on the subject or for any other reason or in case any mistake is found with regard to announcement of result of any candidate or any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This should be incorporated in the promotion/appointment letters issued.
- 2. The selection has been made based on merit in the examination vis-à-vis date of birth has been made as next criterion in case of equal marks of two or more candidates and the order candidate has been given preference over the younger candidate as per instructions of Directorate issued vide letter no. 04-08/2019-SPN-I dated 11.12.2020.
- 3. If any disciplinary/vigilance case is pending against the candidate, the prescribed instructions of the department may be followed before effecting promotion under intimation to this office. Divisional Heads/Unit Heads must ensure that officials are not undergoing any punishment or any disciplinary case is pending.
- 4. Provisional candidate: The Unit/Divisional Heads are requested to immediately finalize the candidature of provisional candidates so that they may not have to wait for the result inordinately. It may be ensured that no provisional candidate is found in the list of selected candidates and if found in the list of selected candidates, they should not be given promotion/appointment under any circumstances without regularization of candidature and the same may be brought to the notice of Circle Office, Patna.



- 5. It is informed that the name of the candidates have been arranged in the order of merit and their allotment to the Division/Unit as per order of preference in accordance with Directorate guidelines issued vide letter no.17-08/2018-SPN-I dated 18.10.2023.
- 6. The names of candidates against the Roll No. concerned has been shown as furnished by the Divisional/Unit Heads. If, however, any mistakes in he Name/Roll No./Community of any candidate are noticed, the same may be corrected under intimation to this office.
- 7. Promotion order will be issued to the successful candidates clearly indicating that if the official does not join the promotional post within seven (07) days it will be deemed to have been refused. Official on leave may be allowed to join even after seven days if they communicate in writing to accept the promotion and in that case the official will be allowed after expiry of approved leave period (Controlling officers are advised to contact such successfull candidates who are on leave for obtaining their consent to join promotional post in writing Similarly, candidates who do not wish to join promotional posts may be encouraged to communicate the same in writing.
- 8. If any discrepancies/irregularities/omissions found in name, Roll No., Marks, Community etc. at any stage against any candidate, the result of the said candidate to be cancelled
