In pursuance of the Postal Directorate letter no A-34012/03/2024-DE dated 10.07.2024, notification for conducting Limited Departmental Competitive Examination (LDCE) for promotion to the cadre of Postman and Mail Guard from eligible Multi Tasking Staff officials for the vacancy year 2024 (01.01.2024 to 31.12.2024) was issued vide this office letter no. R&E-19/Postman-MG/MTS/2024 dated 15.07.2024.

2. Vacancy position for the above LDCE was notified vide this office letter of even number dated 02.09.2024.
3. As per schedule announced, the examination for Paper-I, Paper-II & Paper-III was conducted on 25.08.2024 and Data Entry skill Test (DEST) was conducted on 08.09.2024 at Ranchi.
4. As per Postal Directorate letter no. 17-08/2018-SPN-I dated 05.04.2022 and 17-08/2018-SPN-I dated 19.12.2022, the category-wise minimum qualifying marks for Paper-I, Paper-II, Paper-III and Paper-IV (DEST) are as under:

5. Now, the Competent Authority is pleased to declare the results of candidates successful in the Limited Departmental Competitive Examination, 2024 for promotion to the cadre of Postman and Mail Guard from eligible MTS officials as mentioned in **Annexure-I**. Marks sheet of all MTS candidates who appeared in the LDCE is attached as **Annexure-II**.
6. As per the Postman and Mail Guard Recruitment (Amendment) Rules 2023, notified in GSR 638(E) dated 30.08.2023, Directorate's instructions in letter no. 17-08/2018-SPN-I dated 18.10.2023 & dated 31.10.2023, a single merit list at Circle Level with the successful candidates of the above LDCE is prepared and the selected candidates have been allotted to the Divisions/Units as per merit vis-à-vis order of preference exercised by the candidates subject to availability of vacancies in the Division/Unit.
7. Candidates in the merit list, after joining the Division/ Unit allotted to them will not be eligible for re-consideration for re-allotment to other Divisions / Units (which were their top preferences and could not be allotted due to non-availability of vacancies on their turn) in which vacancies may arise due to declinations and these declination vacancies will be allotted to the next meritorious candidates.
8. Every care has been taken while preparing the result, however if, any discrepancies come to notice, it may be reported to this office immediately before issuing the result to the successful candidates.

9. Offer of promotion will be given by concerned Divisions/Units to selected candidates with the instructions contained in Para 2 (C) and 2(J) of Postal Dte. Letter No. 17-08/2018-SPN-I dated 15.06.2022 must be mentioned, where there is instructions that “ the promotion orders will be issued to the selected candidates clearly indicating that, if the official does not join the promotional post within **07(seven) days, it will be deemed to have been refused.**”

10. In respect of SC/ST candidates, “promotion of the candidates is provisional subject to verification of their caste status. Head of the Unit will take an undertaking from the official to this effect at the time of their relieving and ensure verification of caste status within one month”.

11. On the basis of instructions issued vide Postal directorate letter no. X-7/6/2022-SPN-II dated 17.05.2023:

(i) Candidates against whom no case of suspension, criminal case or departmental cases etc. are pending as on the last date of application and subsequently till the date of declaration of result, are treated as “**Eligible for declaration of result**”.

(ii) Candidates against whom any case of suspension, criminal case or departmental cases etc. were pending as on the last date of application are treated as result in “**Sealed Cover**”.

(iii) Candidates against whom any suspension, disciplinary proceeding or criminal case etc. have subsequently been initiated during the period from the last date of application to the date of declaration of result, are treated as result in “**Deemed Sealed Cover**”.

12. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the head of Divisions/Units. In case there are any mistakes in the details of candidates, the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidates was not eligible to take the examination under the existing rules/instructions on the subject or for any reason or in case any mistake is found with regards to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, the selection will be cancelled without any notice, as the case may be.

13. If any discrepancies/irregularities/omissions found in name, roll no., marks, community etc. at any stage, the result of the said candidate to be cancelled/modified without issuance of any notice.
