Sub: Declaration of result in connection with CE for appointment to the posts of Postman and Mail Guard from eligible GDS candidates for the vacancy year 2024 (01.01.2024 to 31.12.2024) held on 25.08.2024 & DEST held on 14.09.2024.

The Chief Postmaster General, Punjab Circle, Chandigarh is pleased to declare result of CE for appointment to the posts of Postman and Mail Guard from eligible GDS Candidates for the vacancy year 2024 (01.01.2024 to 31.12.2024) held on 25.08.2024 & DEST held on 14.09.2024.

 Instructions contained in Para B of Directorate letter no. 17-08/2018-SPN-I dated 18.10.2023 read with letter dated 31.10.2023, prescribes as under:-

Stage-IV (Unfilled vacancies of Postman /Mail Guard):- After completion of stage-III if still some vacancies are left unfilled, those will be added to the vacancies earmarked for GDS candidate to arrive at the total vacancies for GDS candidates and to decide category-wise vacancies.

Accordingly 39 unfilled vacancies are added to the vacancies earmarked for GDS candidate to arrive at the total vacancies which comes to 172 and notified in <a href="Annexure-II">Annexure-II</a>.

- 2.1 Directorate letter no. 17-08/2018-SPN-I dated 05.04.2022 prescribes as under:-
- a) Performance in both Paper-I and Paper-II (combined, i.e. total of marks secured in Paper-I and Paper-II) will be considered for selection to the posts of Postman / Mail Guard, provided a candidate has qualified in both Paper-III & Paper-IV.
- b) Merit list will be prepared only on the basis of total marks secured in Paper-I and Paper-II. After arranging the candidates in order of merit, number of candidates to be declared successful shall be equal to the number of vacancies in each category.

- 2.3 In those cases where two or more candidates get clubbed due to securing equal marks, their inter-se rank/merit has been decided in the following order:-
  - Inter-se rank/merit will be decided as per date of birth where the older candidate will be placed higher than the younger candidate for all categories including GDS candidates.

ii. In respect of GDS candidate, if date of birth is also same, the person who is senior in the common seniority / gradation list of GDS will be placed higher and if there is no common seniority/ gradation list than the GDS who was engaged earlier on continous basis shall be placed higher in the rank/merit.

- 3. The list of selected candidates in accordance with the merit viz-a-viz preferences exercised viz-a-viz availability of vacancy in respective Division is enclosed as **Annexure-I**.
- 3.1 Vacancy notified against UR Category:- 67 Postman + 4 Mailguard, All vacancies filled amongst meritorious GDS candidates including 1 PwBD.
- 3.2 Vacancy notified against SC Category:- 22 Postman + 0 Mailguard, 17 vacancies filled amongst meritorious GDS candidates including 2 PwBD.
- 3.3 Vacancy notified against OBC Category:- 35 Postman + 0 Mailguard, 15 vacancies filled amongst meritorious GDS candidates. One vacancy kept reserved for one OBC candidate i.e. Mr. Khushpreet Singh (OBC), ABPM Kalbanoo, Patiala Division, Roll No. 812009 was proceeded against under Rule-10(B) of GDS Rules and the case is before the Engaging Authority for final decision. As such his result is not declared and shall be declared on conclusion of disciplinary proceedings, in accordance with Dte. Letter no. 17-47/2024-GDS dated 14.10.2024.
- 3.4 Vacancy notified against EWS Category:- 13 Postman + 0 Mailguard, 03 vacancies filled amongst meritorious GDS candidates.
- 3.5 Vacancy notified against ST Category:- None of the GDS candidates of ST Category appeared in exam, thus all unfilled vacancies of ST Category for the year 2024 shall be reported to Staff Selection Commission (SSC) for recommending candidates through the open recruitment examination conducted by them as per Directorate letter dated 03-03/2019-SPN-(Pt.-I) dated 12.06.2024.
- 3.6 The appointment will be effective after expiry of currency of punishment in respect of such candidates as also mentioned in Remarks column in accordance with Directorate letter no. 17-47/2024-GDS dated 14.10.2024.
- 4. Since, there is no more successful GDS Candidate of PwBDs category, thus, unfilled vacancies of PwBDs for the year 2024 shall be reported to Staff Selection Commission (SSC) for recommending candidates through the open recruitment examination conducted by them as per Directorate letter dated 03-03/2019-SPN-(Pt.-I) dated 12.06.2024.
- Abstract of Vacancies notified, filled and unfilled is attached as Annexure II.
- 6. Final Answer key of Paper I, Paper II and Paper-III is attached as Annexure-III.
- 7. Instruction for joining process of candidates.

All Head of Units of selected candidates are instructed to take necessary action for joining of newly selected candidates as per extant provisions.

Any mistake in the name of candidate, Roll number, Community etc. may be brought to the notice of this office immediately and necessary corrections may be made at your end.

Divisional heads are requested to verify suitability of PwBD candidate, if any, in accordance with Dte letter No.12-10/2017-SCT dated 24.04.2019 before issue of appointment order.

The caste/tribe certificate of the GDS, if belonging to SC/ST category may be verified and it may also be ensured that caste/tribe certificate of the official, if belong to SC/ST is still figuring in the notified central list of Scheduled Caste/Tribe before actually giving him/her appointment orders.

In case of appointment against vacancies reserved for OBC, a clause in the offer of appointment would be inserted to the effect that appointment will be provisional and subject to verification of the community certificate, in accordance with DOPT OM No. 36033/4/97-Estt.(Res.) dated 25.07.2023.

"The appointment is provisional and is subject to the community certificate being verified through the proper channels. If the verification reveals that the claim of the candidate belong to Other Backward Classes or not to belong to creamy layer is false, his/her service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of Bharatiya Nyaya Sanhita(BNS) for production of false certificates".

Similarly, instructions on reservation for Economically Weaker Section (EWS) issued from time to time must be adhered to before actually giving him/her appointment orders.

#### 8. Instruction for candidates who decline offer of appointment.

If any candidate is willing/unwilling to accept offer, he/she should submit his/her willingness/unwillingness to the head of Parent Division in **prescribed** proforma (enclosed) by 28.10.2024, failing which it shall be termed as "deemed declination". Divisional Head should send the copy of unwillingness of such candidates in one lot by 29.10.2024.

- 9. In case, subsequently if it is found that any of the qualified candidate(s) was not eligible to appear in the examination under the extant rules or instructions on the subject or for any other reasons or in case, any mistake is found with regard to announcement of the result of any candidates for any reason whatsoever, his/her name will be deleted from the list of successful candidate, as the case may be. The result is also subject to any change in merit list of the selected candidates due to any unforeseen reasons in accordance with the existing rules on the subject.
- 10. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules & the verification of genuineness of various mandatory certificates of the candidates by the concerned head of the unit. Before relieving an official to join post of Postman /Mailguard, Divisional Head shall follow the guidelines issued vide Directorate letter no. 17-47/2024-GDS dated 14.10.2024.
- 11. It is enjoined upon all concerned that appointment orders shall be issued on 21.10.2024.
