In pursuance of Postal Directorate letter No. A-34012/02/2024-DE dated 10.07.2024, the notification for Limited Departmental Competitive Examination for promotion to the cadre of Postman from eligible MTS was issued vide this office letter No. ADPS/CON/2-13/2024/Postman dated 12.07.2024

2. As per schedule announced, the examination for Paper-I, Paper-II& Paper-III was conducted on 25.08.2023 and Paper-IV (DEST) was conducted on 25.09.2023 for the recruitment year 2024 at three Examination Centers viz. Jammu, Srinagar & Ladakh.

3. As per Postal Directorate letter no. 03-03/2019-SPN-I (Pt.I) dated 12.06.2024, the unfilled vacancies of Postman cadre for the year 2023 has been included into vacancy position of Postman cadre for the vacancy year 2024 and accordingly as per available vacancy position reported by divisions, the tentative vacancy of MTS to Postman cadre was issued vide this notification no. even dated 12.07.2024.

4. Thereafter, the additional vacancies in Postman cadre have been occurred due to promotion of Postman cadre officials into PA/SA cadre after the declaration of result of LGO Examination 2024. The resultant final vacancies of MTS to Postman cadre for the year 2024 are as under: -

5. As per Postal Directorate letter No. 17-08/2018-SPN-I dated 05.04.2022 and letter no. 17-08/2018-SPN-I dated 19.12.2022, following parameters has been followed while preparing the result of Postman cadre: -

6. Result has been made as per instruction of Postal Directorate issued vide letter No. 17-08/2018-SPN-I dated 18.10.2023 and dated 31.10.2023, based on marks secured in Paper-I & Paper-II (collectively) only. Paper-III & Paper-IV are considered as qualifying in nature and the marks secured in Paper-III & Paper-IV has not been taken into account for assessment of merit.

The selected candidates have been allotted to the Divisions/Units as per merit 7. (category wise, i.e. UR, SC, ST, PwD) vis a vis order of preferences exercised by the candidates subject to availability of vacancies in the Division/Unit.

While preparing the result, where the marks obtained by the candidates in Paper-I 8. & Paper-II (collectively) are same, the inter-se rank/ merit has been decided as per instruction contained in Postal Directorate letter no. 04-08/2019-SPN-I dated 11.12.2020.

Now, the Competent Authority has been pleased to announce the result of 9. candidates who had appeared in the MTS to Postman examination held on 25.08.2024 & 25.09.2024 annexed as Annexure-I.

Offer of appointment/promotion order in respect of successful candidates will be issued by the concerned Divisions/Units i.e. concerned appointing authority to the selected candidates giving 07 days' time to candidate(s) to either accept or refuse the offer/order. If a candidate(s) does not give his/her acceptance or refusal within stipulated time it shall be deemed to have been refused and accordingly supplementary result will be declared and vacancies will be offered to next eligible available candidate as per RRs. The provision of 'deemed refusal' shall be communicated to the candidate.[Controlling officers are advised to contact successful candidates who are on leave for obtaining their consent to join promotional post in writing. Similarly, candidates who are not willing to join the promotional posts may also be encouraged to communicate the same in writing.]

While issuing offer of appointment/appointment letter to the candidate the Divisional Heads shall ensure that the person appointed to the post shall have/acquire a driving license to drive two-wheeler or three wheeler or light motor vehicle within a period of two years from the date of his appointment. However, persons with disability shall be exempted from the requirement of driving license. A candidate not having valid snan be exempted nom use fait driving license at the time of appointment shall not earn periodical increment in pay till ariving license at the time of of i production of such license or for a period of five years from the date of appointment

whichever is earlier and after the production of such license or expiry of such five years period, pay shall be restored prospectively to the level pay would have reached had the periodical increment in pay was not withheld and no arrears of pay shall be paid for the intervening period. [This condition is required for recruitment to the cadre of Postman only]

12. The information related to Names of the candidates, their roll number and community have been shown on the basis of information furnished by the Heads of Division/Unit. The Heads of the Division/Units are requested that particular of successful candidate viz. their names, roll number, community and their eligibility are re-checked before issuing offer of appointment. If any discrepancy has been found the same shall be corrected and matter should be reported to this office.

13. The Divisional heads are requested to immediately finalize the candidature of **provisional candidates** if any, so that they may not have to wait for the result inordinately. However, it shall be ensured that <u>no provisionally permitted candidate is given appointment without regularization of his/her candidature</u>. The concerned units are requested to verify the current status of the selected candidate before promoting/appointing him/her.

14. In case, it is subsequently found that any of the selected candidate (s) was not eligible to the take the examination under the extant rules or instructions on the subject or for any other reasons or in case any mistake is found with regard to announcement of result of any candidate for any reason whatsoever, his /her name will be deleted from the list of successful candidates, as the case may be. This should be incorporated in the promotion /appointment letter to be issued by the Divisions.

15. The selected candidates should note that the selection to the post of Postman cadre is provisional subject to satisfactory verification of credential like Date of Birth, Educational Qualification, Caste Certificate etc. If later on at any stage it may come to notice of the authority that any of these candidates are not eligible to take the examination, under the rules or instructions on the subject or if the result of the candidate is found not correct for any other reasons, his/her name will be deleted from the selection list.

16. Further in respect of selected reserved category candidates, the Appointing Authority is required to obtain category certificate in the prescribed format as prescribed by Central Government of India and issue appointment orders only after the verification of category certificate and after the completion of other formalities as required under rules for all selected candidates.

17. Divisional Heads /Units are requested to issue formal orders/appointment orders immediately and before giving appointment to the selected candidates, it may ensure that the newly recruited candidates fulfill all required conditions of relevant Recruitment Rules.

Also, the Divisional Heads are advised to recheck the prerequisite condition prescribed for application forms.

18. Before appointment, it should be ensured that, no disciplinary /vigilance/criminal case is pending or contemplated or punishment is current against the selected candidates.

19. In case, at any time, it is detected that the candidate so selected had applied and appeared in examination with false declaration or data, his/her selection will be cancelled without notice.
