In pursuance of Directorate letter No. A-34012/03/2024-DE dated 10.07.2024 and this office notification No. R&E/2-19/2024 dated 12.07.2024, 31.07.2024 and No. R&E/1-7/2024 dated 12/15-07-2024, 31.07.2024 & 23.08.2024, a Competitive Examination (single common examination for appointment of GDS to Postman / Mail Guard and MTS cadre) for recruitment to the cadre of Multi Tasking Staff(MTS) for the vacancy year 2024 (01-01-2024 to 31-12-2024) was held on 25-08-2024.

2. The provisional keys of the examination were published on 25.08.2024 & final answer keys of Paper I was declared vide letter No. R&E/1-7/2024 dated 02.09.2024 and displayed at India Post website. The minimum qualifying criteria prescribed by Directorate in Letter no: 17-08/2018-SPN-I dated 05.04.2022 & 19.12.2022 for Competitive Examination for Appointment to MTS cadre and in accordance with the Standard Operating Procedure issued by Directorate vide letter no. A-34012/02/2022-DE dated 11.08.2022 are as follows:

The minimum qualifying criteria prescribed by Directorate for the Cadre of MTS is as follows:

**Due to deletion of 1 question in Paper I maximum marks for Paper I is revised as 98 instead of 100 and accordingly qualifying marks is fixed as above in accordance with Directorate Letter No.A- 340 12 / 02 / 2022 -DE dated 21.09 .2023.*

3. This has reference to Addendum dated 22.11.2024 & Corrigendum to Addendum dated 23.11.2024. As per the reports received from Regions/units, the vacancies have been revised. As per the report of BG (HQ) Region, the ST category in MMS Bengaluru unit has been changed from 01 to Zero and vacancy in respect of OBC category is changed from zero to 01. Accordingly, the Competent Authority is now pleased to announce the results of Competitive Examination (single common examination for appointment of GDS to Postman / Mail Guard and MTS cadre) held for MTS cadre on 25-08-2024 based on the updated vacancies furnished by Regions/units. Details of revised vacancies announced for recruitment of MTS on the basis of Competitive Examination by Direct Recruitment held on 25-08-2024 and approved by Competent authority is enclosed as **Annexure-I**. The names of the candidates declared successful for recruitment to the cadre of MTS as per Circle Merit in Paper-I are enclosed as **Annexure-II**.

4. The results are declared based on the Department of Posts, MTS Recruitment Rules, 2018 as amended from time to time, SOP vide letter No. A-34012/02/22-DE dated 11.08.2022, model notification issued by Directorate vide letter No.34012/03/2024-DE dated 10.07.2024 and Notification issued vide this office Letter(s) No. R&E/1-7/2024 dated 12-07-2024 & 31.07.2024 and R&E/2-19/2024 dated 12.07.2024 & 31.07.2024 & relevant rules and instructions issued by the Department from time to time.

5. As per Postal Directorate letter No.17-08/2018-SPN-I dated 18.10.2023 (Procedure for selection of candidate based on single examination for posts of Postman/Mail Guard and MTS), the result is compiled taking the scores of Paper-I. The provisionally selected candidates are allotted to the Divisions/Units as per Circle merit in **Paper I** [Category wise, UR, SC, ST, OBC & EWS) vis-a vis order of preference exercised by the candidates subject to availability of vacancies in the respective Cadre & Division/Unit. Directorate's Instructions issued vide letters No.17-08/2018-SPN-I dated 5.4.2022, 19.12.2022; 18.10.2023 & 31.10.2023 has been taken into account for selection of candidates as per Circle Merit.

6. *The GDS candidates appeared for recruitment to the cadre of both Postman and / or Mail Guard and MTS in the single common examination for appointment of GDS to Postman / Mail Guard and MTS cadre held on 25-08-2024 and declared successful to the cadre of Postman or Mail Guard in the said examination and already joined the post of Postman or Mail Guard **have not been** considered for appointment to the cadre of MTS as per the Guidelines issued by the Directorate.*
7. The names of the candidates have been arranged in the order of Circle Merit in the examination. The inter-se rank/merit of the candidates who have secured equal marks has been decided as per Directorate instruction / guidelines in letter No. 04-08/2019-SPN-I dated 11-12-2020.
8. Gradation list should be prepared at Divisional level as per the guidelines on the subject.
9. Regions are requested to verify the relevant particulars of the selected candidates at their own level. In case, it is subsequently found that any of the qualified candidate (s) was not eligible to take the examination under the extant rules or instructions on the subject for any other reasons or in case any mistake is found with regard to list of qualified candidates for any reason whatsoever, the action taken may be brought to the notice of Circle Office.
10. The information relating to vacancies, name(s) of the candidate(s), their roll number(s) and category(ies) etc., have been shown on the basis of information furnished by the Region/Division/Units. **In case there are any mistakes in the details of vacancies, candidate(s) etc., the same may be intimated to this office for necessary action.**
11. **In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the merit list of successful candidate's due to any unforeseen reason in accordance with the existing rules and instructions on the subject or orders of Hon'ble CAT/High Court, if any."**
12. The provision of reviewing of results of failed SC/ST candidates has been revisited by the Postal Service Board and decided to discontinue, as communicated vide Postal Directorate letter No. 4-13/2015-SPN-I dated 08-04-2016.
13. Results of candidates claiming SC/ST/OBC/EWS/PH status may be thoroughly verified and any discrepancy noticed may be intimated to Circle Office. The candidates of reserved category i.e., SC/ST who are shown as qualified on merit and selected against UR vacancies should be adjusted against UR vacancies in the Roster. The candidates claiming age relaxation under SC/ST/OBC category have been selected against their respective categories.
14. The category of the candidates may be rechecked with reference to the Government of Karnataka order No SWD 713 SAD 93 dated 11-03-2002 communicated vide this office letter No. STA/26-1/5/Rlgs/VII/PT dated 22-05-2003.
15. The selection and **appointment** of the candidate belonging to OBC/EWS/SC/ST is subject to verification of their caste status by the divisions concerned, as per extant instructions on the subject.
16. The Divisional/Unit Heads, before giving appointment to the selected candidates should ensure that the selected candidates fulfil all required conditions of relevant Recruitment Rules of Multi-Tasking Staff 2018 and as amended from time to time. Also, the Divisional / Unit Heads are advised to re-check the pre-requisite conditions prescribed for candidates with reference to the recommendations made.
17. It may be **ensured that no provisional candidate is given appointment without regularization of their candidature.** The Divisions/Regions are requested to verify the current status of the candidature of

the qualified candidates before appointing the candidate. *The candidate against whom vigilance or disciplinary case is pending/those undergoing punishment **should not be appointed** and such cases should be referred back to Circle office.*

18. The selection of the candidates is purely provisional subject to the fulfilment of required conditions of relevant recruitment rules & verification of genuineness of various mandatory certificates of the candidates by the concerned head of the unit.

19. The appointing authorities are requested to carry out all the required pre-appointment formalities as provided in relevant rules and instructions issued from time to time on the subject.

20. Since the examination has been conducted using OMR answer sheets, the request for re-totaling / re-valuation will not be entertained. Photo copies of answer papers will be supplied to the candidates on submission of application under RTI Act 2005. Applications other than under RTI Act, 2005 for supply of photo copies will not be entertained.

a) Candidates who wish to have the copies of OMR answer sheets supplied are required to pay a fee of Rs. 25 /- per paper plus Rs. 10/- towards fee for application under RTI Act,2005 in the post office and submit their applications to CPIO / Assistant Director (R&E), O/o Chief Postmaster General, Bengaluru – 560 001 through their respective Division / Unit (through proper channel only) along with the receipt of payment of fee in original.

b) The period of preservation of OMR answer sheet is **one year** from the date of declaration of **Main** result. Therefore applications received after one year for supply of photo copies of answer sheet will not be entertained by the department.

c) Photocopies of OMR answer sheet will be supplied only to the candidates who appeared for the examination. Therefore, the candidate should invariably intimate their roll no. in the application under RTI Act.

21. The Divisional Heads may ensure that provisional appointment orders are issued to the candidates immediately. *While issuing the appointment order, the term **“APPOINTMENT”** only to be used. The term **“PROMOTION”** Should NOT be used any-where in respect of these GDS candidates.*

22. The Regional/Divisional Heads are requested to obtain the declaration of those candidates who are declining the selection as MTS, if any on or before 30.11.2024 and also provisional appointment orders to the successful candidates may be issued on or before **02.12.2024**.

23. The Divisional / Unit heads are also requested to ensure timely issuance of appointment letters so that candidates can join their respective offices of posting at the earliest. The guidelines issued vide Directorate letter No. W-04/2/2020-SPN-I-Part(1) dated 19-10-2020 may be taken into consideration while issuing appointment orders.

24. Details of vacancies notified, filled and remained unfilled by category wise may be intimated by **02.12.2024** for taking further action of surplus allotment of candidates of other recruiting units in the Circle.

25. Results of provisionally recommended candidates are kept in sealed cover. The divisional/ unit heads are requested to finalize the candidature of provisionally recommended candidates and intimate the details of such candidates to Circle office through concerned Region at the earliest so as to take further action on these cases.

26. This office reserves the right either to modify/delete or cancel the name/provisional selection of any of the candidates, if any of the candidate(s) is found not eligible or if found necessary for any cause at a later date. ***For such an order this will be the notice issued in advance. No separate notice will be issued whenever modification/revision/deletion/cancellations are ordered.***

27. In accordance with the instructions contained in Directorate's letter No. W-17 /10/2023-SPN-I-DOP dated 06.03.2023, the candidates who were declared successful appointment, but had declined their appointment already and have again been declared successful through this Examination for appointment to

MTS cadre for the vacancy year 2024, will be provisionally appointed **only after completion of one year from the date of last declination**, even if they are allotted divisions.

28. The Region/ Divisions/units are requested to verify the current vigilance status of the above qualified candidates as per Directorate's letter No. X-7/6/2022-SPN-II dard 17.05.2023 as amended vide letter No.X-7/6/2022SPN-II dated 22.09.2023 and 04.03.2024 and intimate the status of candidates. The candidates are eligible for appointment
