Sub: Declaration of result in connection with CE-2024 for recruitment to the cadre of MTS from eligible GDSs against vacancies for the year 2024 (01.01.2024 to 31.12.2024).

The Chief Postmaster General, Punjab Circle, Chandigarh is pleased to declare the result in connection with CE-2024 for recruitment to the cadre of MTS from eligible GDSs against vacancies for the year 2024 (01.01.2022 to 31.12.2024).

2. Instructions contained in Para G of Directorate letter no. 17-08/2018-SPN-I dated 18.10.2023 read with letter dated 31.10.2023 envisage as under:-

Stage – VI (List of GDS Candidates for the post of MTS):- List of Successful GDS candidates (Merit list) for the posts of MTS, equal to number of vacancies in each category, shall be published. Process of appointment to the selected post/ refusal of offer of appointment, similar to the process at Stage-II and III above will be repeated. This process will be repeated till all the vacancies are exhausted or qualified GDS candidates are not available for appointment.

2.1 Directorate letter no. 17-08/2018-SPN-I dated 05.04.2022, indicating criteria of selection, envisage that performance in Paper-I only will be considered for selection to the post of MTS. Dte. Letter no 17-08/2018-SPN-I dated 10.07.2024 has reviewed the syllabus and pattern of the Examination and it has been decided the component of Local Language test (Paper-III) for the post of MTS shall be dispensed with.

2.2 Minimum Qualifying Marks

Category	Qualifying criteria	Paper-I
OC	40% in each paper	37.6 (Out of 94 marks)
OBC/EWS	37% in each paper	34.78 (Out of 94 marks)
SC/ST/PwBD	33% in each paper	31.02 (Out of 94 marks)

2.3 In case of direct recruitment including the appointment of Gramin Dak Sevak (GDS) on regular basis to another post, viz. MTS, Postman, Postal Assistant etc., Inter-se Rank/merit may be decided in the following order:-

i. Inter-se rank/merit will be decided as per date of birth where the older candidate will be placed higher than the younger candidate for all categories including GDS candidates.

ii. In respect of GDS candidate, if date of birth is also same, the person who is senior in the common seniority /gradation list of GDS will be placed higher and if there is no common seniority / gradation list than the GDS who was engaged earlier on continuous basis shall be placed higher in rank / merit.

3. The list of selected candidates in accordance with merit viz-a-viz preferences excersie viz-a-viz availability of vacancies in respective division is enclosed in Annexure-I.

3.1 Vacancies notified against UR Category:- One vacancy of UR has been filled amongst meritorious PwBD as elaborated below. Remaining 80 vacancies were filled amongst meritorious GDS candidates.

5. **Instruction for joining process of candidates.**

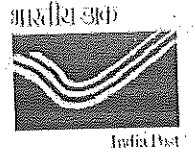

Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and who's family has gross annual income as prescribed, are to be identified as EWS for benefit of reservation, in accordance with Dte letter no. 17-09/2019-GDS dated 26.02.2019. Divisional Heads are requested to verify certificates of EWS candidates before issue of appointment orders.

7. Instruction for candidates who accept/decline the offer.

If any candidate is willing / unwilling to accept offer, he/she should submit his/her willingness/ unwillingness to the head of Parent Division in prescribed Performa (enclosed) on or before 21.11.2024, failing which it shall be termed as "deemed declination". Divisional Head should send the copy of willingness/unwillingness of such candidates in one lot by 22.11.2024.


8. In case, subsequently if it is found that any of the qualified candidate(s) was not eligible to appear in the examination under the extant rules or instructions on the subject or for any other reasons or in case, any mistake is found with regard to announcement of the result of any candidates for any reason whatsoever, his/her name will be deleted from the list of successful candidate, as the case may be. The result is also subject to any change in merit list of the selected candidates due to any unforeseen reasons in accordance with the existing rules on the subject.

9. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules & the verification of genuineness of various mandatory certificates of the candidates by the concerned head of the unit. **Before Joing of GDS on departmental Post, Divisional Heads shall check to ensure that the GDS is not falling any one or more categories mentioned bellow in accordance with Dte. Letter no 17-47/2024-GDS dated 14.10.2024:-**

- i. **GDS is Putt off Duty;**
- ii. **GDS in r/o whom Charge sheet has been issued and disciplinary proceedings Is pending and**
- iii. **GDS in r/o whom prosecution for a criminal charge is pending.**
