I am directed to forward the result of **Competitive Examination for direct recruitment to the cadre of Postman/Mail Guard from eligible GDS for the vacancy year 2024 (01.01.2024 to 31.12.2024) held on 25.08.2024 & DEST held on 15.09.2024 as Annexure – "A".**

2. Approved final division-wise vacancies of Postman/Mail Guard from eligible GDS for the vacancy year 2024 is enclosed as annexure-"B". The summary of filled and unfilled vacancies is attached as annexure "C". Five vacancies under PwBD category remained unfilled due to non-availability of qualified candidates.

3. Allotment of Divisions/Units to selected candidates has been made as per instructions contained in Directorate letter No. 17-08/2018-SPN-I dated 18.10.2023 & 31.10.2023. This allotment is also subject to change, if any discrepancy found in allotment later on.

4. In case of bunching inter se rank/ merit has been decided on the basis of date of birth as per guidelines contained in Dte letter No 04-08/2019-SPN-I dated 11.12.2020.

5. The information relating to names of the candidates, their roll numbers, categories, post-categories, date of birth and date of appointment have been shown on the basis of information furnished by the Regions/Divisions/Units. In case, there are any mistakes in the details of candidates, the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the promoted/ selected candidate was not eligible for the examination/selection under the existing rules/ instructions on the subject or for any other reasons or in case any mistake is found with regard to declaration of result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to any change in the

merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject.

6. The result of all successful candidates is subject to fulfillment of eligibility criteria to be decided by the concerned Divisional/Unit Head and vigilance status of the candidates. The officials/candidates against whom vigilance or disciplinary case is pending/ those undergoing punishment should not be promoted and such cases should be referred back to this office as per directions of Directorate's Letter No. X-7/6/2022-SPN-II dated 17.05.2023, 22.09.2023 and 04.03.2024.

7. Final Answer Keys of above examination have already been uploaded in the Departmental website i.e. www.indiapost.gov.in on 06.09.2024.

8. All the Divisional Heads/Appointment Authorities are requested to cause issuance of promotion/appointment orders immediately. The appointment authorities are also requested to carry out all the required pre-appointment formalities as provided in relevant rules and instructions issued from time to time.


9. Divisional/Unit Heads are requested to take immediate necessary action for joining of newly selected candidates as per extant provisions. The Divisional/Unit Heads are requested not to send separate letter of carrying out joining process/appointment letters to Circle Office. The joining process should be completed on or before 10.01.2025.

10. Divisional /Unit Heads concerned are directed to submit the unwillingness/refusal of the candidate by 10.01.2025 positively. If any Division/Unit especially which the candidate is presently working is failed to submit the refusal within stipulated time to Circle Office, they will be held responsible for that.

11. Request for revised allotment of any candidate will not be entertained.

All Divisional/Unit heads are requested to display the above result on the office notice board.




