Category (B):

(i) Officials holding post in Level 1, Level 2 and Level 3 of the Pay Matrix with total regular service of eight (08) years including service rendered regularly as Gramin Dak Sevaks.

Provided that for officials holding post in Level 1, Level 2 and Level 3 of the Pay Matrix, who have rendered regular service as Gramin Dak Sevaks on or before 17.06.2022, the total regular service including the service rendered regularly as Gramin Dak Sevaks shall be five (05) years.

Note 1: Eligibility of service condition shall be as on 01.01.2025.

Note 2: The officials mentioned at Category (B) above, will be considered only if sufficient officials mentioned at Category (A) are not available for filling up the notified vacancy.



Reference is invited to above stated subject and Department of Personnel and Training's (DoP&T) instructions regarding grant of exemption to physically handicapped candidates to appear in Data Entry Skill Test (DEST) [DOPT OM No. 14020/1/2014-Estt.(D) dated 22.04.2015]:

FOR FOR PARTING

- (i) If a physically handicapped candidate is otherwise qualified to hold the said post and is certified by the competent Medical Authority i.e. the Civil Surgeon of a Government Health Care Institution, that he is permanently unfit for the Typing Test (DEST) because of a physical disability, may be exempted from passing the DEST.
- (ii) The term physically handicapped does not cover those who are visually handicapped or who are hearing handicapped but cover only those whose physical disability permanently prevents them from typing."
- 2. Earlier, vide letter No.17-08/2018-SPN-L dated 19.09/2022, U.P. Circle was advised to take appropriate action based on the abovementioned instructions of DoP&T. However, keeping in view the practical difficulties for VH candidates and principle of natural justice, the matter was re-examined and it was decided that VH candidates shall be exempted from appearing in DEST. These instructions were communicated to all Postal Circles vide letter of even number dated 11.10.2022.
- 3. In continuation of above letter dated 11.10.2022, it may further be noted that exemption granted to VH candidates for appearing in DEST shall be made applicable to all VH candidates, from recruitment year 2022 onwards. In cases where Data Entry Skill Test (DEST) has already been held for recruitment year 2022. VH candidates who have appeared for DEST shall be taken as qualified for the said examination.

G.S.R. 459(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Department of Posts (Postal Assistant and Sorting Assistant Group 'C' Non-Gazetted) Recruitment Rules, 2015, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the posts of Postal Assistant (Circle Office and Regional Offices), Postal Assistant (In the Foreign Post Organisations in Chennai, Delhi, Kolkata and Mumbai),

Postal Assistant (Savings Bank Control and Internal Check Organisations), Postal Assistant (Post Office) and Sorting Assistant (Railway Mail Service) in the Ministry of Communications, Department of Posts, namely:-

- 1. Short title and Commencement. (1) These rules may be called the Department of Posts (Postal Assistant & Sorting Assistant) Recruitment Rules, 2022.
- (2) They shall come into force on the date of their publication in the official Gazette.
- 2. Number of posts, their classification and level in the pay matrix. The number of posts, their classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. **Method of recruitment, age-limit, qualifications etc.** The method of recruitment, age-limit, qualifications and other matters relating to the said posts shall be as specified in columns (5) to (13) of the said Schedule.
- 4. **Disqualification**. No person, -
- (a) who, has entered into or contracted a marriage with a person having a spouse; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. **Requirement to serve.** Any person appointed to the posts specified in the said Schedule shall be liable to serve anywhere in India including in Army Postal Services.
- 6. **Power to Relax.** Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving. Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-Serviceman, Other Backward Classes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

This condition shall not be applied with reference to such junior officials who lost their seniority after availing transfer under Rule-38 of the Postal Manual Volume-IV.";

- (d) against serial number 5, relating to the post of Sorting Assistant (Railway Mail Service), under column (11), for Note 3, the following Note shall be substituted, namely: -
 - "Note 3: Where juniors who have completed qualifying or eligibility service are eligible for Limited Departmental Competitive Examination or Competitive Examination, their seniors would also be eligible for such examination provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade subject to the condition that both the senior and junior were recruited through same mode of recruitment and were holding same feeder cadre prior to appointment to the present post on regular basis.

This condition shall not be applied with reference to such junior officials who lost their seniority after availing transfer under Rule-38 of the Postal Manual Volume-IV.".

Subject: Transfer to lower posts under the provision of Fundamental Rule, 15(a) — clarification.

I am directed to say that vide letter of even number dated 18.11.2019, detailed guidelines have been issued for considering the request for transfer to lower post under Fundamental Rule 15(a).

2. As per guidelines, Chief Postmaster General of concerned Postal Circle has been made the Competent Authority to decide the such representations. Further, Competent Authority has the discretion to accept or reject such request.

3. Due to provision of protection of pay in certain type of cases as mentioned in letter dated 18.11.2019, it is observed that request for transfer to lower post under FR 15(a) is being submitted in routine nature with intent to get the benefit of pay protection of higher posts while working in lower posts. Transfer to lower post with protection of pay drawn in higher posts entails additional financial burden on Public Exchequer. Accordingly vide said letter dated 18.11.2019, all Circles have been advised not to invoke the provision of FR 15(a) in a routine manner and cases involving protection of pay be examined on case to case basis and shall be approved on rarest of the rare cases for reasons to be recorded on the file.

4. However, it has come to notice of this office that request for transfer to lower posts are being approved in a routine manner which is not desirable as per the guidelines issued vide letter dated 18.11.2019.

5. Further, DOPT OM No. 20011/1/2008-Estt(D) dated 10.11.2010 – [Fixation of seniority of a person who has been transferred to a lower post under FR-15(a)] says that:

"When the Government employee is transferred to a lower post on his own request under FR 15(a)(2), it neither, identifies itself as a case of penal action on the employee nor as a case of transfer to a lower post in public interest. As the person already stood promoted to the next higher grade, in case of his/her reoccupying the lower post at the top of the seniority (original position), would affect adversely not only the existing officers in the grade, but would apparently nullify the very purpose of his /her transfer to the lower post. As such an officer seeking transfer to a lower post under FR-15, at his own request, would be placed below all officers appointed regularly to the lower grade on the date of transfer".

- 6. As per the above guidelines, seniority of such official who seeks the transfer to lower posts under FR 15(a) is to be fixed below all officials appointed regularly to the lower grade on the date of transfer.
- 7. Further, it has come to notice that such official who got transfer to lower posts is being made eligible for promotion by counting his/her service from the date of joining in lower post at initial stage. Senior officials who has not completed requisite length of service are also being considered for promotion with reference to such junior official who got transfer to lower post and placed at the bottom of seniority list.
- 8. This issue has been examined in light of DOPT OM dated 20011/1/2008-Estt(D) dated 10.11.2010 as mentioned above, which say that seniority of such official who seeks transfer to lower posts under FR 15(a) is to be fixed at the below all officers appointed regularly to the lower grade on the date of transfer. In view of this principle, an official who sought transfer to lower grade under FR 15(a) needs to put up a fresh service from the date of appointment to lower post after transfer from higher post, to become eligible for promotion to higher posts whether on seniority cum fitness basis or LDCE quota. Accordingly, junior/senior condition will not arise with reference to such official as such official will not become eligible till completion of a fresh spell of requisite length of service.
- 9. Circles are advised to take action accordingly.
