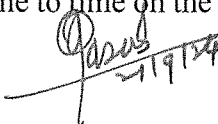

Note: In case, it is subsequently found that any of the selected candidate(s) was not eligible to take the examination under the extant rules or instructions on the subject or for any other reasons or in case any mistake is found with regard to announcement of result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This should be incorporated in the promotion/appointment letters issued.

2. Merit list of the selected candidates has been prepared as per their marks obtained in Paper I and Paper II (combined) and also subject to their qualifying in Paper III & Paper IV (DEST).
3. The selection of candidates in Annexure – I is subject to fulfilment of conditions mentioned in Notification of examinations and relevant Recruitment Rules amended from time to time. There will be no re-allocation in any circumstances.
4. Directorate vide memo no SC/12/9/2022/SCT/DOP dated 14.09.2022 has issued instructions on reservation in promotion to persons with Bench mark disabilities (PwBD) which inter-alia specifies that “ *in view of the clarification received from DoP&T and with the approval of the Secretary (Posts), it has been decided that the prospective vacancy year for implementation of the ibid DoPT OM dated 17.05.2022 would be the year 2023 i.e. reservation in promotion for PwBDs in accordance with DoP&T ibid OM dated 17.05.2022 will be implemented prospectively from the vacancy year 2023 starting w.e.f 1st January, 2023*”.
5. It is the personal responsibility of the Appointing Authorities to carry out verification of valid documents i.e., Date of Birth proof, educational qualification certificates, PWD certificate, respective Category Certificate, Category Validity Certificates etc. and other eligibility conditions for respective vacancy year, as per ruling on the subject before issuing provisional appointment orders to the selected candidates.
6. In case, at any time, if it is detected that the candidate so selected had applied and appeared the examination with false declaration relating to educational qualification, category, length of service and physical disability etc., his/her selection will be cancelled without any notice.
7. If it is later noticed that the permission granted to any candidate to appear for the examination was not valid due to one or the other reasons, as per the orders on the subject, the candidature will be cancelled without any notice and his/her name will be removed from the list of successful candidates at any stage.
8. The Divisional Heads should ensure issuance of offer of appointment letter to the successful candidates within a specified date, so that the selected candidates/officials may join in their respective office of posting within 7 days as per procedure for selection of candidate based on single examination for the post of MTS/Postman/Mail Guard mentioned in Directorate letter no. 17-08/2018-SPN-I dated 18.10.2023& 31.10.2023 and other extant rules. If the official does not join the promotional post within seven (07) days it will be deemed to have been refused. Controlling Officer shall immediately relieve the official to join promotional post. Official on leave may be allowed to join even after Seven (07) days if they communicate in writing to accept the promotion and in that case the official will be allowed to join after expiry of approve leave period. (Controlling officers are advise to contact such successful candidate who are leave for obtaining their consent to join promotional post in writing. Similarly, candidates who do not wish to join promotional post may be encouraged to communicate the same in writing.)
9. The Appointing Authorities are requested to carry out all the required pre-appointment formalities as provided in relevant rules and instruction issued from time to time on the subject

Also the Divisional/Unit Heads are requested to re-check the pre-requisite conditions prescribed for candidates, with reference to their recommendations made while forwarding the application forms.

10. Before appointment, it should be ensured that, no disciplinary/ vigilance case is pending or contemplated or punishment is current against the selected/ allotted candidates. If any, such case should be referred to this office immediately.

11. The Name, Category and other details of the candidates have been shown as furnished by the concerned Region/Division/Unit. However, if any mistake in the Name/Roll No./Category etc. is noticed, the same may be confirmed under intimation to this office.

12. It may be ensured that no provisionally permitted candidate is given appointment without regularization of his/her candidature. The Divisions/Units are requested to verify the current status of the candidate of the qualified candidates before appointment.

13. If name of any candidate not recommended for declaration of result, is found in selection list, the same may be immediately brought to the notice of this office for immediate necessary action.

14. Since there is no reservation for OBC & EWS category in Departmental quota and unfilled vacancies of Departmental quota are being offered to GDS, the candidate belongs to OBC & EWS who fulfils required eligibility criteria of UR category are selected against UR with remark as selected against UR based on their Merit position.

15. As regards to Departmental APS candidates, it may be ensured by the APS authorities that the APS candidates on their discharge from APS are appointed in the Unit/Division shown in the respective Annexure after completing pre-appointment formalities such as verification of caste and imparting training. The Division/Unit heads will please issue NBR certificate with effect from the date of his junior is appointed in PM-MG cadre. All other instructions on the subject issued from time to time may kindly follow.

16. Regions/Units are directed to follow the instructions for issuing offer of promotion and ascertaining joining activities in seven days as per Directorate letter No 17-08/2018-SPN-I Dated 18.10.2023 & 31.10.2023. The time line is as under:

- i. Issue the offer of promotion – by 24.09.2024
- ii. Inform the unfilled vacancies due to non-joining of candidates to Region: 03.10.2024.
- iii. Consolidated report by Regions to CO : 04.10.2024

Concerned Regional APMG/AD will monitor the above timelines personally and will arrange to submit certified unfilled vacancies to CO for further processing of result.

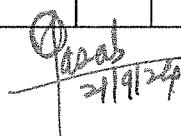

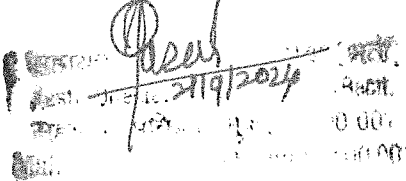
