CORRIGENDUM

In partial modification to this office letter no. Rectt/R-2/LGO Exam/2025 dated 18.09.2025, wherein the final result of LDCE/CE for promotion/recruitment to fill up the vacancies of PA/SA cadre from eligible officials for the vacancy year 2025 i.e. 01.01.2025 to 31.012.2025, was declared, the following changes are made:

- (i) The name of the candidate listed/selected at serial no. 93 in the final result issued on 18.09.2025 i.e. Sh. Sandeep Kumar (UR), Roll No. 1502011 (MTS, Delhi North Division) **needs to be deleted** since the said candidate had wrongly darkened / bubbled the PH(Others) sub category bubble in the OMR Answer Sheet due to which the said candidate got selected in the result under PH(Others) category although the candidate is of UR Category and has secured only 47 marks and the cutoff marks of the UR category as per merit are 49.
- (ii) Consequently the name of Sh. Parvinder Dalal, who figured next to the last selected candidate in merit list, now added at Serial No. 90 in the result issued on 18.09.2025, in place of candidate mentioned at (i) above. The details of Sh. Parvinder Dalal are enclosed herewith as Annexure-I.
- (iii) In view of the changes above, the candidates listed at Sl. No. 90, 91 & 92 in the result declared on 18.09.2025 may be read as listed at Sl. No. 91, 92 & 93.
- (iv) The rest of the contents of the letter of even no. dated 18.09.2025 stands good.
