Sub: Limited Departmental Competitive Examination (LDCE) for Promotion to the posts of PA/SA for the vacancy year 2025 held on 17.08.2025 followed by the DEST on 14.09.2025- Declaration of Final result

Reference is invited to this office letter of even no. dated 09.09.2025 whereby the list of candidates shortlisted (03 times of vacancies) on the basis of marks of Paper-I was published. The Data Entry Skill Test (DEST) for the candidates who shortlisted in Paper-I was held on 14.09.2025. The Competent Authority has directed the undersigned to declare the final result of above said examination on merit basis of marks obtained in Paper-I and DEST qualified as per vacancies notified. The result of the selected candidates in **Annexure-I** is enclosed herewith.

2. In pursuance of Directorate instructions contained in letter No. 17-08/2018-SPB-I dated 10.05.2019, the candidates who qualify in Paper-I & DEST separately shall be considered for final selection and their Merit shall be drawn in the order of marks secured in Paper-I as DEST is qualifying in nature. Also, as per the Recruitment Rules 2022 of PA/SA cadre, notified in GSR 459 (E) dated 17.06.2022, communicated vide Dte. letter no. 04-05/2015-SPN-I dated 20.06.2022, and Directorate's instructions in letter No. X-12/6/2021-SPN-II dated 31.12.2021, a single merit list at Circle Level is prepared and the selected candidates have been allotted to the Divisions/Units as per merit (category wise, i.e., UR, SC & ST) vis a vis order of preference exercised by the candidates subject to availability of vacancies in the Divisions/Units.
3. Since the above Limited Departmental Competitive Examination is meant for filling up of vacancies under departmental promotion quota, no reservation for OBC, EWS categories is applicable as per the extant rules/guidelines on the subject.
4. Offer of appointment/promotion order will be issued by concerned Divisions/Units to selected candidates by 23.09.2025 with clear directions to either accept or refuse the offer by 26.09.2025 by 1200 hrs.
5. In case of deciding of inter-se rank/merit in case of more than one candidate scoring equal marks, instructions contained in Directorate's letter No. 04-08/2019-SPN-I dated 11.12.2020 has been followed and accordingly Inter-se rank/merit has been decided for all categories.
6. The information relating to the Names of the candidates, their Roll numbers and Community have been shown on the basis of information furnished by the Heads of Division/Units. The Head of the Divisions/Units are requested that particulars of Successful candidates, viz. Roll numbers, names, community and their eligibility to appear in the said examination, are re-checked before issuing offer of appointment. If any discrepancy is found the same may be corrected and the matter should be reported to this office. The Divisions/Units will also check that number of such candidates allotted to their Units is not more than the number of vacancies proposed to be filled through the said examinations.

7. In case, if it is found subsequently that any of the selected candidate(s) was not eligible to appear in the examination under the existing Rules/Instructions on the subject or for any reasons or in case any discrepancy is found with regard to announcement of Result of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be.

8. **In respect of SC/ST candidates**, "promotion of the candidates is provisional subject to verification of their caste status. Head of the Unit will take an undertaking from the officials to this effect at the time of their joining and ensure verification of caste status within one month".

9. Any discrepancy found in respect of any item, the matter should immediately be reported to this office.

10. This result is also subject to any change in merit list of selected candidates for any reason in accordance with the existing Rules and Instructions on the subject. It may be ensured that **no Provisional candidate is given appointment without regularization of the candidature** and such cases need not to be kept pending except in very exceptional & unavoidable circumstances.

11. No GDS candidate is selected in GDS to PA/SA Examination for the year 2025.


