The Competent Authority is pleased to declare the results of the Limited Departmental Competitive Examination (LDCE) for promotion to the posts of Postal Assistant (Circle Office), Postal Assistant (Post Office) and Sorting Assistant from eligible officials of Category A, Category B and Competitive Examination from eligible GDS candidates for the vacancy year 2025 (01-01-2025 to 31-12-2025) held on 17.08.2025 and DEST held on 14.09.2025.

2. The provisional and final answer keys were displayed in the departmental website on 17.08.2025 & 02.09.2025 respectively. Directorate vide letter nos. 17-08/2018-SPB-I dated 10-05-2019, No. 17-08/2018-SPN-I dated 19-12-2022 and as amended from time to time, has specified the paper-wise qualifying percentage. On the basis of this percentage, the detail of qualifying marks for vacancy year 2025 is as under:

3. Since, this is a promotional examination and no reservation in promotion for OBC and EWS candidates, hence, the minimum qualifying percentage of UR category will be applicable for them.

4. The following is the vacancy position in PA (CO) / PA (PO) / SA cadres under Departmental Promotion Quota for the vacancy year 2025 in accordance with the extant rules/guidelines issue by Directorate from time to time, and the Division/Unit-wise vacancy position was already published vide this office notification memo no. R&E/77-8/2025 dated 06.06.2025 under Recruitment & Results in the Departmental website.

5. The LDCE/CE results are declared based on the Department of Posts (Postal Assistant & Sorting Assistant) Recruitment Rules, 2022 issued by Directorate vide F. No. 04-05/2015-SPN-I dated 20-06-2022 & as amended from time to time, SOP vide letter no. A-34012/02/22-DE dated 11-08-2022 and Notification issued by this office vide letter no. R&E/77-8/2025 dated 06-06-2025.

6. In pursuance to instructions contained in Directorate letter No. X-12/6/2021-SPN-II dated 31-12-2021, selection of candidates through examination has been done by preparing a single merit list at Circle Level. The procedure for selection of candidates for the post of PA/SA on the basis of LDCE as envisaged by Directorate vide letter no. W-04/8/2022-SPN-I dated 26-10-2023 has been followed for allotment of successful candidates. The selected candidates have been allotted to the divisions/units as per merit (category wise, UR, SC & ST, PwBD) vis-à-vis order of preference exercised by the candidates subject to availability of vacancies in the respective Division/Unit and as per their turn of allotment.

7. The results containing list of the successful candidates of Category A, Category B and Category C (arranged in the Circle-wise merit order) is shown in Annexure I. The *inter se Rank / merit* of candidates have been decided as per Directorate's letter No.04-08/2009-SPN-I dated 11-12-2020. The result is also available in the Departmental website (www.indiapost.gov.in).

7.1 The status of filled and unfilled vacancies is appended as Annexure II.

8. Candidates have been allotted to the extent of vacancies notified for vacancy year 2025 except 01 PwBD horizontal vacancies viz., 01 "HH" Category under SA(RMS) Cadre due to non-availability of qualified PwBD Candidates in the merit list. The said vacancy is carried forward to be filled-up in the next vacancy year 2026 as per guidelines issued to fill-up PwBD vacancies. While allotting candidates under PwBD vacancies, DoP&T instructions contained in letter no. 36035/02/2017-Estt(Res) dated 27-09-2022 and Postal Directorate letter no. X-20/17/2024-SPN-II dated 19.07.2024 have been kept in view.

9. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Heads of Division/Unit. In case there are any mistakes in the details of candidate(s), the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever, his/her name will be removed from the list of selected candidates, as the case may be.

10. In accordance to instructions contained in Directorate's F No.W-17/10/2023-SPN-I-DOP dated 06-03-2023, the candidates who were declared successful through LDCE for promotion to PA/SA Cadre and had declined their promotion for vacancy year 2024 and have again been declared successful through LDCE for promotion to PA/SA Cadre for vacancy year 2025 should be promoted only after completion of their embargo period.


11. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Divisions/Units are requested to verify the current status of the candidature of the qualified candidates before promoting the official. The official/candidate against whom vigilance or disciplinary case is pending or those undergoing punishment should not be promoted and such cases should be referred back to this office as per Directorate's letter no. X-7/6/2022-SPN-II dated 17-05-2023 and amended from time to time.

12. All the Divisions / Units should issue promotion and allotment order to the successful candidates of Annexure – I by 22-09-2025. The successful candidates may be directed to accept/decline their place of posting on promotion by 26th September 2025 in the proforma attached, failing which, their promotion will be deemed declined.

13. All the Heads of Divisions / Units of selected candidates are instructed to take immediate necessary action for joining of newly selected candidates. The Divisional/Unit heads are requested not to send separate letter of carrying out joining process/appointment letters to Circle Office. The joining process to be completed on or before 30-09-2025.

14. Final answer Keys {A, B, C & D series} of the above said exam are already uploaded in the Departmental websites - www.indiapost.gov.in on 02.09.2025.
