Sub: Declaration of result of Limited Departmental Competitive Examination / Competitive Examination for recruitment to the cadre of PA/SA from eligible Postman / Mail Guard, MTS and GDS held on 17.08.2025 and DEST on 18.09.2025 for the vacancy year 2025 (01.01.2025 to 31.12.2025).

In pursuance of Circle Office, Bhopal Notification cited under reference examination for recruitment to the cadre of PA/SA from eligible Postman / Mail Guard, MTS and GDS held on 17.08.2025 and DEST on 18.09.2025, the result has been compiled taking the scores of Paper-I as merit and Data Entry Skill Test (DEST) as qualifying for the purpose of selection.

The provisional answer key for Paper-I (in Series A, B, C & D in both papers) inviting responses from candidates were uploaded in India Post Website and widely circulated to all Units in the Circle. The Moderation Committee has examined the responses received from candidates in details and thereafter the answer keys for Paper-I have been finalized and final Answer Key was uploaded in India Post Website and widely circulated vide this office letter of even no. dated 29.08.2025.

As per instructions of Directorate vide letter no. 17-08/2018-SPB-I dated 10.05.2019, the selection has been made strictly on merit based on marks secured in Paper-I only and DEST is considered as qualifying in nature.

As per the Recruitment Rules 2022 PA/SA cadres notified in GST 459 (E) dated 17.06.2022, communicated vide Directorate letter no. 04-05/2015-SPN-I dated 20.06.2022 and in pursuance of Directorate letter No. X-12/6/2021-SPN-II dated 31.12.2021, a single merit list has been prepared at Circle level with the successful candidates of the above LDCE/Competitive Examination and the selected candidates have been allotted to the Divisions/Units as per merit (Category-wise i.e. UR, SC & ST) vis a vis order of preference excercised by the candidates subject to availability of vacancies in the Divisions/ Units.

In case of deciding of inter-se rank/merit in case of more than one candidate scoring equal marks, instructions contained in Directorate's letter No. 04-08/2019-SPN-I dated 11.12.2020 has been followed and accordingly inter-se rank/merit has been decided.

The vacancies of Postal Assistant / Sorting Assistant have been notified in Notification dated 09.06.2025 under Departmental promotion quota for the vacancy year 2025 in accordance with the extant rules / guidelines issued by Directorate from time to time.

NOTE:

In case, it is subsequently found that any of the selected candidate (s) was not eligible to take the examination under the extant rules or instructions on the subject or for any other reason or in case any mistake is found with regard to announcement of result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This should be incorporated in the promotion/appointment letters issued.

The selection of candidates in Annexure-I & II are subject to fulfillment of all conditions of relevant recruitment rules for recruitment to the cadre of Postal Assistant / Sorting Assistant.

As per Para 3 of Directorate letter no. W-17/10/2023-SPN-I-DOP New Delhi Dated 06.03.2023 (Copy enclosed), an official who has refused an offer of promotion shall be allowed to appear in the LDCE for next vacancy year. However, if such an official figure in the merit list for promotion, offer of promotion shall be issued till completion of one year from the date of refusal of earlier offer of promotion. While declaring list of successful candidates for promotion on the basis of results of LDCE, the date from which such an official will be eligible for promotion shall be mentioned appropriately. In this context all the instructiones of the said letter should be followed strictly.

The Divisional Heads must declare the formal result and appointment order on or before 01.10.2025 to the candidates must be issued immediately. Further the Divisional Heads will send the final joining status of the candidate latest by 06.10.2025 to this office. And, before giving appointment to the selected candidates will see that, the newly recruited candidates fulfill all required conditions of relevant Recruitment Rules. Also, the Divisional/ Unit Heads are advised to re-check the pre-requisite conditions prescribed for candidates, with reference to their recommendations made while forwarding the application forms.

- 1. Before, appointment, it should be ensured that, no disciplinary/vigilance case is pending or contemplated or punishment is current against the selected candidates.
- 2. In case, at any time, it is detected that the candidate so selected had applied and appeared the examination with false declaration or data, his/her selection will be cancelled without notice.
- 3. The names of the candidates and their Roll numbers have been shown on the basis of information furnished by the concerned division/ unit. In case any mistake in the names of the candidates is noticed later on, the same may please be corrected and the corrections may be intimated to this office also. It is later on found that any of the selected candidate was not eligible to take the examination under the existing rules or instructions on the subject for any other reason or in case any mistake is later on found with regard to announcement of the result

- of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates/ list of candidates having been allowed concession under the existing rules, as the case may be. This result is also subject to any change in the merit list of selected candidates due to future re-totaling and verification of answer books in accordance with the existing rules and instructions.
- 4. The marks of the provisionally permitted candidates will not be disclosed until and unless their provisional candidature is regularized by the respective Divisions/Units. This may be made clear to all the concerned.





In this context, primarily following issues need to be decided -

- a) whether an official, who had refused offer of promotion, will be eligible for appearing in LDCE for the next vacancy year; and
- b) if allowed and such official qualifies in the LDCE, at what point of time the official will be issued offer of promotion?
- As per prevailing Government instructions [Department of Personnel & Administrative Reforms OM No.22034/3/81-Lstt(D) dated 01.10.1981]. an official who has refused promotion shall not be issued fresh promotion orders for a period of one year from the date of such refusal.
- Taking into consideration the available Unvernment instructions, it is clarified as under:
 - a) An official who has refused an offer of promotion shall be allowed to appear in the LDCE for next vacancy year.
 - b) However, if such an official figures in the merit list for promotion, offer of promotion shall not be issued till completion of one year from the date of refusal of earlier offer of promotion.
 - c) While declaring list of successful candidates for promotion on the basis of results of LDCE, the date from which such an official will be eligible for promotion shall be mentioned appropriately.
