Sub:- Regarding Limited Departmental Competitive Examination (LDCE) for promotion to the posts of Postal Assistant (Circle Office/Regional Offices), Postal Assistant (Post Office) and Sorting Assistant (Railway Mail Service) from eligible officials and Competitive Examination for recruitment to the cadre of Postal Assistants and Sorting Assistants from Gramin Dak Sevaks (GDSs) for unfilled LDCE vacancy of Postal Assistant and Sorting Assistant for the vacancy year 2025 (01.01.2025 to 31.12.2025), held on 17th August, 2025 and DEST held on 07.09.2025- **Declaration of final result of Bihar Circle.**

In pursuance of Postal Directorate letter No. DE-12/1/2025-DE-DOP dated 30.05.2025 and Circle Office Patna letter no. R&E-52/LGO Exam/2025 dated 05.06.2025 & letter no. R&E-52/LGO Exam/2025(GDS), the notification for LDCE/CE for promotion/recruitment to the cadre PA/SA from eligible Postman/Mail Guard/MTS & GDSs was issued. The examination of Paper –I was conducted on 17.08.2025(Sunday) and Paper-II(DEST) was on 07.09.2025(Sunday).

Now, the results has been prepared as per guidelines issued by Postal Directorate, New Delhi letter no. 17-08/2018-SPB-I dated 10.05.2019 & 20.06.2019, letter no. 04-08/2019-SPN-I dated 11.12.2020, letter no. 17-08/2018-SPN-I dated 19.12.2022 and X-7/6/2022-SPN-II dated 17.05.2023.

2. On Successful completion of aforesaid examination, provisional answer keys (MCQ) for Paper-I (in series A,B,C & D) inviting feedback/challenges from candidates were uploaded on Indiapost website on 17.08.2025. Based on responses received from the candidates and recommendation of moderation committee answer keys for Paper-I was finalized and uploaded on Indiapost website on 26.08.2025.

3. Following are the qualifying criteria for Paper-I for LDCE from PM/MG/MTS to PA/SA Examination:-

5. The following are the qualifying criteria for Paper-II (Data Entry Skill Test) DEST for PA/SA as per Dte. letter no. 17-08/2018-SPN-I dated 19.12.2022.

6. Total 78 vacancies (PA-66 + SA-12) have been reported vide Assistant Director (Staff), Circle Office, Patna letter no. Staff/PA-SA/Vacancy/2025 dated 08.07.2025. on the basis of said vacancies, list of qualified candidates who have secured minimum qualifying marks in Paper-I and are eligible for Data Entry Skill Test (DEST), has been prepared and published vide this office letter of even no. dated 28.08.2025. accordingly, the final result to the post of PA/SA have been prepared.

7. In pursuance of Postal Directorate letter no. 17-08/2018-SPB-I dated 10.05.2019 read with letter no. ibid dated 26.06.2019 result has been prepared based on merit in accordance with marks secured in Paper-I only and minimum qualifying marks obtained in Paper-II(DEST), which is annexed as Annexure-I for needful.

8. INSTRUCTIONS

- (I) In case, it is subsequently, found that any of the selected candidate(s) was not eligible to take the examination under the extant rules or instructions on the subject or for any other reason or in case any mistake is found with regard to announcement of result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates., as the case may be, this fact should be incorporated in the promotion/appointment letters issued.
- (II) In case of Departmental employees, selection has made as per direction mentioned in Para 2(A) of Postal Directorate letter no. 04-08/2019-SPN-I dated 11.12.2020.
- (III) If any disciplinary/vigilance case is pending against any of the candidate, the prescribed Instructions of department may be followed before effecting promotion under intimation to this office. Divisional Heads/Unit Heads must ensure that officials are not undergoing any punishment or any disciplinary case is pending.
- (IV) Provisional Candidate : The Unit/Divisional Heads are requested to immediately finalize the candidature of provisional candidates so that they may not have to wait for the result inordinately. It may be ensured that no provisional candidate is found in the list of selected candidates, and if found in the list of selected candidates, they should not be given promotion/appointment under any circumstances without finalization of candidature and the same may be brought to the notice of Circle Office, Patna.
- (V) It is informed that the name of the candidates have been arranged in order of merit and their allotment to the Division/unit as per order of preference in accordance with Directorate guidelines issued vide letter no. X-12/6/2021-SPN-II dated 31.12.2021.

- (VI) In respect of SC/ST/PH candidates, " promotion of the candidates is provisional subject to verification of their status. Head of the Unit will take an undertaking from the officials to this effect at the time of their relieving and ensure verification of caste/PH status within one month.
- (VII) As per Directorate letter no. W-04/2/2020-SPN-I-Part (i) dated 19 October, 2020 Postman/MTS/GDS selected for appointment to the posts of PA/SA, whether through Competitive examination or seniority, shall be appointed straightway after completing pre-appointment formalities without waiting for completion of prescribed institutional induction training.
- (VIII) The Divisional Heads/Unit Heads will ensure submission of refusal (if any) duly signed by him within a week of publication of result. After that application for refusal will not be entertained.

The Divisional/Unit Heads will take further necessary action for circulation of the content of this communication to all concerned and ensure completion of appointment process within one week.
