In pursuant to Assam Circle notification no. Staff/8-58/2025 dated 09.06.2025 and Staff/8-60/2025 dated 09.06.2025 the competent authority is pleased to declare the result of Limited Departmental Competitive Examination (LDCE) for promotion to the post of Postal Assistant and Sorting Assistant held on 17.08.2025.

3. As per schedule of notification the examination was held on 17.08.2025 at Guwahati and Dibrugarh and Data Entry Skill Test [DEST] was conducted on 27.09.2025 at Cotton University.

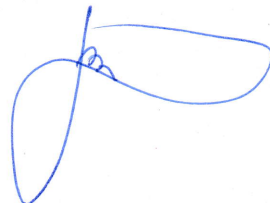
4. As per Postal Directorate letter no.17-08/2018-SPB-I dated 10.05.2019 and letter no.17-08/2018-SPN-I dated 19.12.2022, the category-wise minimum qualifying percentage for Paper-I and DEST is as under:

5. As per postal Directorate letter no.17-08/2018-SPB-I dated 10.05.2019 amended vide Postal Directorate letter no. 17-08/2018-SPN-I dated 29.05.2024, only marks of Paper-I has been taken for considering the merit of qualified candidates. The marks secured in paper-III (DEST) are of qualifying nature only.

6. As per recruitment rules of Postal Assistant and Sorting Assistant cadre notified in GSR 459(E) dated 17.06.2022, communicated vide Postal Directorate letter no. 04-05/2015-SPN-I dated 20.06.2022 and Postal Directorate instructions issued vide letter no. X-126/6/2021-SPN-II dated 31.12.2021 and Postal Directorate letter no. W-04/8/2022-SPN-I dated 26.10.2023, a single merit list of LDCE candidates [Category A then Category B] has been prepared for the Circle and candidates have been allotted to Divisions/units as per merit and order of preferences exercised by the candidates subject to availability of vacancies in the Division/unit.

7. In case, candidates have obtained same marks in Paper-I their inter-se merit has been decided as per instructions in Postal Directorate letter no.04-08/2019-SPN-I dated 11.12.2020. The latest vigilance clearance reports from all Divisions/units have been taken into consideration while preparing the results.



8. The result of the successful candidates selected for the post of Postal Assistant and Sorting Assistant in from LDCE (Category A and Category B) candidates is enclosed as **Annexure-A**. One vacancy in PA cadre under PwBD VH quota could not be filled due to non-availability of candidate under PwBD VH quota.

9. The candidates who have not bubbled the Roll Numbers properly on their OMR sheets have been rejected as the system could not capture their actual Roll Numbers. Also, the candidates who have left their Paper Series blank or have multiple bubble in Paper Series have been awarded zero(0) marks by the system.

10. The concerned controlling authorities are requested to issue posting order(s) to the candidates immediately as per their allotment in Annexure-A and the concerned appointing authorities are requested to issue promotion order/offer of appointment to the candidates on or before **08.10.2025**. All concerned authorities must ensure that candidates selected are relieved immediately on issue of posting orders to enable them to join new place of posting by **15.10.2025**. Instructions shall also be issued to candidate(s) to either accept or refuse the offer of appointment in writing. If a candidate does not give his/her acceptance or refusal within a period of 01(one)week it shall be deemed to have been refused and accordingly supplementary result will be declared and post will be offered to next eligible candidate. The process of acceptance, joining and declination must be completed by **15.10.2025** and no further extension will be allowed.

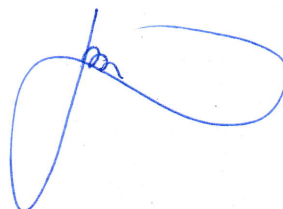
11. In case, at any time it is found that any of the selected candidate(s) was not eligible to appear in the examination under the extant rules or instructions on the subject or for any reasons or in any case any mistake is found regard to announcement of result of any candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This should be incorporated in the promotion/appointment letter to be issued by the Divisions/units.

12. The selected candidates should note that the selection to the post of Postal Assistant/Sorting Assistant is provisional subject to satisfactory verification of the details such as education qualification, case, length of service, physical disability and any other eligibility condition as per notification. If at any stage, it is noticed that the selected candidates(s) are not eligible to take the examination, under the rules or instructions on the subject or if the result of the candidate is found incorrect for any other reasons, his /her name will be deleted from the selection list.

13. Further, in respect of selected reserved category SC/ST/PwD candidates, the appointing authority is required to obtain and verify the category certificate in the format prescribed by Govt. of India.

14. Appointing authorities are requested to issue formal orders of appointment as per para 10 above and before giving appointment to the selected candidates, it may be ensured that the candidates fulfil all required conditions of relevant Recruitment Rules.

15. The information related to Name of candidate, Roll Number, category etc. has been shown on basis of information furnished by the concerned Divisions/units and the application forms of the candidates. The concerned Divisions/units are requested to re-check the particulars of the successful candidate such as Name, Roll Number, Category etc. before issuing the offer



of appointment. If any discrepancy is noticed the same shall be corrected and matter to be reported to Circle Office.

16. Before appointment, it should be ensured that, no disciplinary / vigilance case is pending or contemplated, or punishment is current against the selected candidate. The candidate against whom any vigilance or disciplinary case is pending or those undergoing punishment should not be promoted/appointed. The particular of such candidate shall be reported to Circle Office with full details immediately.

17. In case, at any time, it is detected that the candidate so selected had applied and appeared in the examination with false declaration or data, his/her selection will be cancelled without notice.
