The Chief Postmaster General, Punjab Circle, Chandigarh is pleased to declare result of LDCE for promotion to the posts of Postman and Mail Guard from eligible Multi-Tasking Staff officials for the vacancy year 2025 (01.01.2025 to 31.12.2025) held on 31.08.2025 & DEST held on 25.09.2025.

2. Instructions contained in Para B of Directorate letter no. 17-08/2018-SPN-I dated 18.10.2023 read with letter dated 31.10.2023, prescribes as under:-

"Stage-I (List of MTS candidates for vacancies of Postman / Mail Guard):- Publication of list of successful MTS candidates (merit list) for the posts of Postman and Mail Guard, equal to the number of vacancies in each category separately".

2.1 Directorate letter no. 17-08/2018-SPN-I dated 05.04.2022 prescribes as under:-

- Performance in both Paper-I and Paper-II (combined, i.e. total of marks secured in Paper-I and Paper-II) will be considered for selection to the posts of Postman / Mail Guard, provided a candidate has qualified in both Paper-III & Paper-IV.
- Merit list will be prepared only on the basis of total marks secured in Paper-I and Paper-II. After arranging the candidates in order of merit, number of candidates to be declared successful shall be equal to the number of vacancies in each category.

2.2 Minimum Qualifying Marks

2.3 In those cases where two or more candidates get clubbed due to securing equal marks, there inter-se rank/merit may be decided in the following order:-

- In case of the officials belonging to different feeder cadres, official on the higher grade will be higher in rank than the official in the lower grade.
- In case of the officials belonging to same feeder cadre where there is common seniority/gradation list, official senior in such list will be higher in rank than the official junior in the list.
- In case of the officials belonging to same feeder cadre where there is no common seniority/gradation list, date of joining in the feeder cadre will be the criteria i.e the official who had joined the feeder cadre earlier will be higher in rank.


- iv. In case of the officials belonging to different feeder cadre with identical pay level, the date of joining in the feeder cadre will be the criteria i.e the official who had joined the feeder cadre earlier will be higher in rank.
 - v. In case of (iii) & (iv), if there date of joining in the feeder cadre is also the same, the date of birth will be the criteria i.e the person who is older will be placed higher than the younger.
3. The list of selected candidates in accordance with the merit viz-a-viz preferences exercised viz-a-viz availability of vacancy in respective Division is enclosed as **Annexure-I**.
- 3.1 Vacancy notified against UR Category:- 36 posts were filled amongst meritorious MTS candidates. 01 post of UR has been kept reserved due to administrative reason Remaining 22 posts will be added to vacancies to be offered to GDS candidates as per RRs.
- 3.2 Vacancy notified against SC Category:- 06 posts of SC Category have been filled amongst meritorious MTS candidates of SC Category. Remaining 05 posts will be added to vacancies to be offered to GDS candidates as per RRs.
- 3.3 Vacancy notified against ST Category:- None of the MTS candidates of ST Category appeared in exam, thus all 5 unfilled vacancies of ST Category will be added to vacancies to be offered to GDS candidates as per RRs.
- 3.4 Horizontal reservation of PwBDs:- None PwBD candidate selected against any post. Thus, Horizontal reservation of PwBD vacancies alongwith unfilled vacancies shall be offered to GDS candidates as per RRs.
- 3.5 Mr. Sahil Sondhi, MTS Tower Town, Jalandhar Division Roll no. 708002 (OC) has been allowed provisionally in accordance with interim order dated 29.08.2025 in OA No. 060/00894/2025. As per orders of the Hon'ble CAT Bench Chandigarh, his result is kept in sealed cover.
4. Abstract of Vacancies notified, filled and unfilled is attached as Annexure II.
5. Final Answer key of Paper I, Paper II and Paper-III is attached as Annexure-III.
6. **Instruction for joining process of candidates.**

All Head of Units of selected candidates are instructed to take necessary action for joining of newly selected candidates as per extant provisions.

Any mistake in the name of candidate, Roll number, Community etc. may be brought to the notice of this office immediately and necessary corrections may be made at your end.

Divisional heads are requested to verify suitability of PwBD candidate, if any, in accordance with Dte letter No.12-10/2017-SCT dated 24.04.2019 before issue of appointment order.

The caste/tribe certificate of the promoted official, if belonging to SC/ST category may be verified and it may also be ensured that caste/tribe certificate of the official, if belong to SC/ST is still figuring in the notified central list of Scheduled Caste/Tribe before actually giving him/her promotion.

7. Instruction for candidates who decline promotion.

If any candidate is willing/unwilling to accept promotion, he/she should submit his/her willingness/unwillingness to the head of Parent Division in **prescribed** Proforma (enclosed) by 06.10.2025, failing which it shall be termed as "deemed declination". Divisional Head should send the copy of unwillingness of such candidates in one lot by 07.10.2025.

8. In case, subsequently if it is found that any of the qualified candidate(s) was not eligible to appear in the examination under the extant rules or instructions on the subject or for any other reasons or in case, any mistake is found with regard to announcement of the result of any candidates for any reason whatsoever, his/her name will be deleted from the list of successful candidate, as the case may be. The result is also subject to any change in merit list of the selected candidates due to any unforeseen reasons in accordance with the existing rules on the subject.


9. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules & the verification of genuineness of various mandatory certificates of the candidates by the concerned head of the unit. Before relieving an official to join higher post on promotion and giving appointment to the promotion post, Divisional Heads shall check to ensure that the official is not falling any one or more categories mentioned below in accordance with Directorate letter no. X-7/6/2022-SPN-II dated 17.05.2023 read with letter dated 22.09.2023 & 04.03.2024.

- a) Government servant under Suspension.
- b) Government servant against whom a charge sheet has been issued and the disciplinary proceedings are pending; and
- c) Government servant against whom prosecution for a criminal charge is pending.

10. It is enjoined upon all concerned that Promotion/appointment orders shall be issued on 06.10.2025 as scheduled by the Directorate vide letter no. A-34012/04/2025-DE dated 18.08.2025.
