- (i) Applicants are required to indicate the order of preference for Cadre and then give order of Preference for Division/Unit as per instructions issued vide DoP letter No.W-04/8/2022-SPN-I dated 26-10-2023.
- (ii) After giving order of preference for cadre, candidate shall give order of preference of Division/Unit for which they intend to be considered. A candidate shall not be considered for a Division/Unit for which preference has not been submitted by him/ her.
- (iii) Candidate will be considered for the 1st preferred cadre for all opted Divisions/Units followed by 2nd preferred cadre for all opted Divisions/Units and so on.
- (iv) The candidate will be considered against a cadre if the cadre has been opted by him/her subject to fulfilling the eligibility conditions.
