In pursuance of the Postal Directorate letter no DE-12/2/2025-DE-DOP dated 08.07.2025, notification for conducting Competitive Examination (CE) for recruitment to the post of Multi Tasking Staff (MTS) from eligible Gramin Dak Sevaks (GDSs) for the vacancy year 2025 (01.01.2025 to 31.12.2025) was issued vide this office letter no. R&E-19/Postman-MG/MTS/2025 dated 16.07.2025.

2. As per schedule announced, the examination for Paper-I was conducted on 31.08.2025.
3. As per Postal Directorate letter no. 17-08/2018-SPN-I dated 05.04.2022, 17-08/2018-SPN-I dated 19.12.2022 and 2022 and 17-08/2018-SPN-I dated 10.07.2024, the category-wise minimum qualifying marks for Paper-I is as under:

4. Now, the Competent Authority is pleased to declare the results of candidates successful in the Competitive Examination, 2025 for recruitment to the Multi Tasking Staff (MTS) post from eligible GDSs as mentioned in **Annexure-I**.

5. Allotment of Division/Unit to the successful candidates will be declared in due course.

6. As per the Multi Tasking Staff Recruitment (Amendment) Rules 2023, notified in GSR 639(E) dated 30.08.2023, Postal Directorate's instructions in letter no. 17-08/2018-SPN-I dated 18.10.2023 & dated 31.10.2023, a single merit list at Circle Level with the successful candidates of the above Competitive Examination is prepared.

7. The selection of candidates in **Annexure-I** is purely provisional and subject to fulfilment of conditions of relevant recruitment rules for appointment to the cadre of MTS as per directorate instruction contained vide letter No. X-7/6-2022-SPN-II dated 17.05.2023, 22.09.2023, 04.03.2024 and No. 17- 47 / 2024-GDS dated 14.10.2024. In case any official falls under any of the category which attracts provision of "deemed sealed cover", such officials should not be relieved and the matter be immediately reported to this office.

8. Every care has been taken while preparing the result, however, if any discrepancies come to notice, it may be reported to this office immediately before issuing the result to the successful candidates.

9. The information relating to names of the candidates, their roll numbers, date of birth, date of engagement in GDS and categories have been shown on the basis of information furnished by the head of Divisions/Units. In case there are any mistakes in the details of candidates, the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of

the selected candidates was not eligible to take the examination under the existing rules/instructions on the subject or for any reason or in case any mistake is found with regards to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, the selection will be cancelled without any notice, as the case may be.

10. If any discrepancies/irregularities/omissions found in name, roll no., marks, community etc. at any stage, the result of the said candidate will be cancelled/modified without issuance of any notice.


