The Competent Authority is pleased to declare the results of the Limited Departmental Competitive Examination (LDCE) for promotion to the cadre of Postman and Mail Guard from amongst eligible MTS officials of the Circle for the vacancy year 2025 (01.01.2025 to 31.12.2025) held on 31.08.2025 and Data Entry Skill Test (DEST – Paper IV) to qualified candidates in Paper I, II & Paper III held on 23-11-2025.

2. The provisional keys of the examination were published on 01.09.2025, final answer keys of Paper I, II & III(MCQ) were published on 23.10.2025 & revised final answer keys of Paper I were published on 17.11.2025 and displayed at India Post website. The minimum qualifying criteria prescribed by Directorate in Letter no: 17-08/2018-SPN-I dated 05.04.2022 & 19.12.2022 for LDCE for Promotion to Postman/Mail Guard cadre and in accordance with the Standard Operating Procedure issued by Directorate vide letter no. A-34012/02/2022-DE dated 11.08.2022 are as follows:

- **3.** LDCE is a promotional examination and hence no reservation in promotion for OBC and EWS candidates. Hence, the minimum qualifying percentage of UR category will be applicable for them also.
- **4.** The LDCE results are declared based on Department of Posts, Postman and Mail Guard Recruitment Rules, 2018 and as amended vide Postman and Mail Guard Recruitment Rules 2023, Directorate SOP vide letter No. A-34012/02/22-DE dated 11.08.2022, model notification issued by Directorate vide letter No.34012/03/2025-DE dated 08.07.2025 and Notification issued vide this office Letter(s) No. R&E/1-7/2025 dated 16-07-2025 relevant rules and instructions issued by the Department from time to time. The vacancies were notified vide addendum of even no dated 20.11.2025.
- **5.** The Vacancies notified in respect of LDCE promotion to Postman/Mail Guard Cadre are as follows:

6. In pursuance to instructions contained in Directorate letter No.l7-08/2018-SPN-l dated 18.10.2023 and 31.10.2023 and Department of Posts, Postman and Mail Guard Recruitment Rules, 2018 & Department of

Posts, Postman and Mail Guard Recruitment Rules (Amendment), 2023 selection of candidates through examination has been done by preparing a **single merit list at Circle Level**. The selected candidates have been allotted to the Divisions/Units[PwBD / Category wise(UR, SC & ST)] vis-a vis order of preference exercised by the candidates subject to availability of vacancies in the respective Cadre & Division/Unit as per combined merit secured by them in **Paper I + Paper II**. Directorate's Instructions issued vide letters No.17-08/2018-SPN-I dated 5.4.2022, 19.12.2022, 18.10.2023 & 31.10.2023 have also been taken into consideration for selection of candidates as per Circle Merit.

- 7. In pursuance of Directorate's instruction laid down in letter No.17-08/2018-SPN-I dated 05.04.2022, the candidates who qualified in Paper-I & Paper-II, Paper-III and Paper- IV (DEST) separately shall be considered for final selection and the Merit List will be prepared only on the basis of total (combined) marks secured by the candidate in Paper I & Paper II, since Paper-III and Paper-IV (DEST) are qualifying in nature and will not count for deciding the merit in case of tie etc. As per the Department of Posts, Postman and Mail Guard Recruitment Rules, 2018, amended vide Gazette Notification dated 30.08.2023 and Postal Directorate letter No.17-08/2018-SPN-I dated 18.10.2023 and 31.10.2023 (Procedure for selection of candidate based on single examination for posts of Postman/Mail Guard and MTS), the result has been compiled taking the scores of Paper-I and Paper-II (combined) for Circle Merit.
- **8.** Orders/guidelines relating to Reservation in promotion to Persons with Benchmark Disabilities vide DoPT OM No.36012/1/2020-Estt.(Res-II) dated 17.05.2022 & Directorate letter No.X-20/17/2025-SPN-II dated 13.08.2025 along with DoPT OM No.36035/02/2017-Estt (Res) dated 27.09.2025, and other extant rules/guidelines issued by Directorate from time to time have been complied.
- **9.** The results containing list of the successful candidates of LDCE for promotion to the cadre of Postman/Mail Guard as per Circle Merit (Paper I+ Paper II) for vacancy year 2025 (01.01.2025 to 31.12.2025) in respect of LDCE held on 25.08.2025 followed by DEST held on 15.09.2025 are arranged in the Circle merit order and is shown in **Annexure-II.** The inter se rank/ merit of candidates has been decided as per Directorate's letter No.04-08 /2009-SPN-l dated 11.12.2020. Consequent to this, if there is change in the merit list, the same may be communicated to this office for issuing correction. The selection of the candidates is provisional and subject to fulfillment of conditions of relevant recruitment rules for promotion to the cadre of Postman and Mail Guard. The result is also available in the Departmental websites (wrvw.indiapost.gov.in & https://karnatakapost.gov.in). *Candidates who have come in Merit in respective category, but could not be considered for Division/unit allotment due to limited options/ order of preference exercised by the candidates since the vacancies have already been allotted to more meritorious candidates above them on his/her turn of allotment are also indicated in the Results.*
- **10.** Candidates in this merit list who have been allotted Division / Unit and who have joined their allotted division will not be eligible for re-allotment to Divisions / Units (preferred by them) where vacancies may arise due to declination and these declined vacancies will be allotted to the next meritorious candidates below them in the list or to candidates who had initially exercised limited options to these divisions, even though these candidates rank junior / senior to them in ranking.
- 11. The information relating to names of the candidates, their roll numbers and categories etc have been shown on the basis of information furnished by the Heads of Region/Division/Unit. In case there are any mistakes in the details of candidate (s), the same may be corrected and intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidate (s) was /were not eligible to take the Examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be.
- **12.** The Heads of divisions/units are requested that particulars of successful candidates viz Roll Numbers, Names, community and their eligibility to appear in the said examination are re-checked and it should be ensured that the selected candidates who are declared successful, fulfill all required conditions of relevant Recruitment Rules. They will also check that the number of such candidates allotted to their units is not more than the number of vacancies notified in the said examination.

13. This result is also subject to any change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject. This office reserves the right either to modify/delete or cancel the promotion/appointment, if any of the candidate(s) is found not eligible for the promotion/appointment or if found necessary for any cause at a later date. For such an order this will separate notice issued in advance. No notice will be issued whenever modification/revision/deletion/cancellations are ordered.

- **14.** In accordance with the instructions contained in Directorate's letter No. W-17 /10/2023-SPN-l-DOP dated 06.03.2023, the candidates who were declared successful through LDCE for promotion, but declined their promotion and have again been declared successful through LDCE for promotion to Postman/Mail Guard cadre for the vacancy year 2025, should be promoted only after completion of one year(embargo period) from the date of last declination.
- **15.** The selection of the candidates is purely provisional subject to the fulfillment of all required conditions of relevant Recruitment Rules. It may be ensured that no provisional candidate is given promotion/appointment without regularization of their candidature. The Region/ Divisions/units are requested to verify the current status of the candidature of the qualified candidates before issue of promotional/appointment order to the candidates. The official/candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be promoted and such cases should be referred back to Regional Office as per Directorate's letter No. X-7/6/2022-SPN-II dared 17.05.2023 as amended vide letter No.X-7/6/2022SPN-II dated 22.09.2023 and 04.03.2025 with copy to this office.
- **16.** The following condition may also be incorporated in promotion memo as the case may be without fail:

"In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case, any error is found with regard to announcement of results of any candidate for any reasons whatsoever, his/her name will be deleted from the select list, as the case may be. This result is subject to orders in any case pending before any court of law and is also subject to change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject. The appointing authority/this office reserves the right either to modify/delete or cancel the promotion/appointment, if any of the candidate(s) is found not eligible for the promotion/appointment or if found necessary for any cause at a later date. For such an order this will be the notice issued in advance. No separate notice will be issued whenever modification/revision/deletion/cancellations are ordered ".

- **17.** Promotion of selected candidates should be processed expeditiously observing codal formalities, departmental guidelines issued and circulated from time to time. All the Heads of Divisions/Units of promoted candidates are instructed to take immediate necessary action for joining of promoted candidates as per extant provisions. The Divisional/Unit Heads are requested not to send separate letter of carrying out joining process/appointment letters to Circle Office.
- **18.** The successful candidates may be directed to accept / decline their place of posting on promotion by **11-12-2025 in the proforma attached (Annexure-III)**, failing which their promotion will be deemed to be declined. Promotion orders will be issued in case of all successful candidates clearly indicating that if the official does not join the promotional post on or before **13-12-2025**, it will be deemed to have been declined. Official on leave may be allowed to join even after 13-12-2025, if they communicate in writing to accept the promotion and in that case the official will be allowed to join after expiry of approved leave period. The Divisional/Units heads are also requested to ensure timely issuance of joining orders to all the successful candidates on or before 13-12-2025 and joining process must be completed on **15.12.2025**. A consolidated report should be submitted to this office by Regional Offices on 16.12.2025.
- **19**. The Divisional/Unit heads are requested **not** to send separate letter of carrying out joining process/appointment letters to Circle Office.

20. Requests for re-totalling/revaluation will not be entertained in the light of instruction of the Directorate. Photo copies of answer sheets will be supplied to the candidates only, on submission of application under RTI Act, only on furnishing OMR Form No & Roll Number and will be entertained in the following manner:-

- **a)** Candidates, who wish to have the copies of OMR/Answer sheets supplied, are required to pay a fee of Rs.25/- per paper plus Rs.10/- towards fee for application under RTI Act in the Post Office accounts and submit their applications through the Division/Unit concerned along with the receipt for payment of fee in original.
- **b)** A copy of this memo with annexure has been uploaded on www.indiapost.gov.in. Requests for supply of these documents under RTI Act will not be entertained. Final Answer Keys were also uploaded and RTI requests will not be entertained this effect too.
- **c)** The prescribed period of preservation in respect of OMR/Answer sheets is one year from the date of declaration of Main result. Therefore applications received after one year from the date of declaration of main results for supply of photocopies of OMR/Answer sheets will not be entertained.


