In pursuance of Postal Directorate letter no DE-12/1/2025-DE-DOP dated 30.05.2025, notification was issued vide this office letter no. R & E-20/LGO Exam/2025 dated 09.06.2025 for conducting Limited Competitive Examination (LDCE)/ Competitive Exam (CE) for promotion/recruitment to the cadre of Postal Assistant (Circle Office), Postal Assistant (Post Office) and Sorting Assistant (Railway Mail Service) for the vacancy year 2025 (01.01.2025 to 31.12.2025) from eligible officials/GDSs.

2. Now, the Competent Authority is pleased to declare result of candidates successful in the LDCE/Competitive Examination, 2025 held on 17.08.2025 and DEST held on 14.12.2025 for promotion/recruitment to the cadre of Postal Assistant/Sorting Assistant from Postman/Mail Guard/MTS and GDS as mentioned in Annexure I.
3. The vacancy position notified vide notification dated 09.06.2025 remains unchanged.
4. The followings are the qualifying criteria for each paper for LDCE/Competitive examination from Postman-MG/MTS (PO & RMS)/MTS(CO) and GDS to PA/SA cadre:-

Category	Qualifying Criteria	Paper-I
UR	40%	37.20 (Out of 93 marks)
SC/ST/PwBD	33%	30.69 (Out of 93 marks)

The followings are the qualifying criteria for Data Entry Skill Test (DEST) for LDCE (Postman/MG/MTS to PA/SA) and for Competitive Exam from GDS to PA/SA as per Dte. Letter no. 17-08/2018-SPN-I dated 19.12.2022:

Category	Qualifying Criteria	Maximum Marks
UR/OBC/EWS	75% i.e. 18.75	
SC/ST/ PwD	60% i.e. 15	25

5. In pursuance of Directorate instructions contained in Letter No. 17-08/2018-SPB-I dated 10.05.2019 and 17-08/2018-SPN-I dated 29.05.2024, the candidates who qualify in Paper-I and DEST separately shall be considered for final selection and their Merit shall be drawn in the order of marks secured in Paper-I. Also, as per the Recruitment Rules 2022 of PA/SA cadre, notified in GST 459(E) dated 17.06.2022, communicated vide Directorate letter No. 04-05/2015-SPN-I dated 20.06.2022, Directorate's instructions in letter no. X-12/6/2021-SPN-II dated 31.12.2021 and letter no. W-04/8/2022-SPN-I dated 26.10.2023, a single merit list at Circle Level

with the successful candidates of the above LDCE/Competitive Examination is prepared.

6. The information relating to names of candidates, Roll Numbers and categories etc have been shown on the basis of information furnished by the Divisions/Units. In case there are any mistakes in the details of candidates, the same may be intimated to this office for necessary action.
7. Every care has been taken while preparing the result, however if, any discrepancies come to notice, it may be reported to this office immediately before issuing the result to the successful candidates.
8. The names of the candidates have been arranged in the order of merit in the examination. The inter-se rank/merit of candidates who have secured equal marks has been decided as per Directorate's instructions/guidelines in Letter No. 04-08/2019-SPN-I dated 11.12.2020.
12. If any discrepancies/ irregularities/ omissions found in name, roll no., marks, community, etc. at any stage, the result of the said candidate to be cancelled/modified without issuance of any notice.
13. The selection of the candidates is purely provisional subject to the fulfilment of required conditions of relevant Recruitment Rules.




