- 7. The appointing authorities are requested to carry out all the required pre-appointment formalities as provided in relevant rules and instructions issued from time to time on the subject as GDS are outside the civil service. Also, the Divisional/Unit Heads are requested to re-check the pre-requisite conditions prescribed for candidates, with reference to their recommendations while forwarding the applicant forms.
- 8. Before appointment, it should be ensured that, no disciplinary/vigilance case is pending or contemplated or punishment is current against the selected/allotted candidates. If any, suitable action may be taken and such case should be referred to this office immediately through proper channel.
- 9. While issuing promotion/ appointment orders to the candidates selected through the LDCE/LCE, the instructions contained in para 2 (C) and 2 (J) of Postal Dte. letter No. 17-08/2018-SPN-I dated 15.06.2022 must be mentioned, where there is instructions that, the promotion/ appointment orders to the selected candidates to be issued clearly indicating that, if the candidates do not join the post within 7 (seven) days, it will be deemed to have been refused.
