Sub: Declaration of result pertaining to Limited Departmental Competitive Examination (LDCE) for promotion to the posts of Postal Assistant (Circle Office / Regional Offices), Postal Assistant (Post Office) and Sorting Assistant (Railway Mail Services) from eligible officials for the vacancy year 2026 (01.01.2026 to 31.12.2026) held on 28.06.2026 followed by DEST on 02.08.2026.

Ref: Circle Office notifications no. RE/30-23/2026(PA/SA) dated 11.05.2026 and letter of even no. dated 29.05.2026.

In pursuance of the Postal Directorate letter no. DE-12/2/2026-DE-DOP dated 06.05.2026, notification for Limited Departmental Competitive Examination (LDCE) for promotion to the posts of Postal Assistant (Circle Office / Regional Offices), Postal Assistant (Post Office) and Sorting Assistant (Railway Mail Services) from eligible officials for the vacancy year 2026 (01.01.2026 to 31.12.2026) was issued vide this office letter no. RE/30-23/2026(PA/SA) dated 11.05.2026. Further, in accordance with this office letter No. RE/30-23/2026(PA/SA) dated 29.05.2026, the written examination for Paper-I of the aforesaid examination was held on 28.06.2026 followed by DEST on 02.08.2026.

2. The Final Answer Keys (Series A, B, C &D) of Paper-I of the above mentioned examination have already been circulated to all Divisional/Unit Heads vide Circle Office letter no. RE/30-23/2026(PA/SA) (I) dated 24.07.2026 and displayed in Odisha Circle Portal of Indiapost as well.

3. Directorate vide letter Nos. No.17-08/2018-SPB-I dated 10.05.2019, No. 17-08/2018-SPB-I dated 26.06.2019, F. No. 17-08/2018-SPN-I dated 09.09.2021 and No. 17-08/2018-SPN-I dated 19.12.2022 has

specified the paper-wise qualifying marks as under :

4. This is a promotional examination and there is no reservation in promotion for OBC and EWS candidates. Hence, the minimum qualifying percentage of UR category will be applicable for them.

5. The following final vacancy position of Odisha Circle has been circulated vide Circle Office, Bhubaneswar letter no. RE/6-1/2026 dated 22.07.2026 under Departmental promotion quota for the vacancy year 2026 (01.01.2026 to 31.12.2026) in accordance with the extant rules/guidelines issued by Directorate from time to time.

6. In pursuance of guidelines contained in Directorate letter No. 17-08/2018-SPB-I dated 10.05.2019 and letter No. 17-08/2018-SPN-I dated 29.05.2024, the candidates who qualify in Paper- I and Paper -III (DEST) separately shall be considered for final selection and their merit shall be drawn in order of marks secured in Paper -I since Paper -III (DEST) is qualifying in nature.

7. Pursuant to instructions contained in Directorate letter No. X-12/6/2021-SPN-II dated 31.12.2021, selection of candidates through examination has been done by preparing a single merit list at Circle level. The procedure for selection of candidates for the post of PA/SA on the basis of LDCE as envisaged by Directorate vide letter No. W-

04/8/2022-SPN-I dated 26.10.2023 has been followed for allotment of successful candidates. The selected candidates have been allotted to the Divisions/Units as per merit *vis-à-vis* order of preference exercised by the candidates subject to availability of vacancies in the respective Division/Unit and as per their turn of allotment.

8. Now, the Competent Authority is pleased to declare the result of Limited Departmental Competitive Examination (LDCE) for promotion to the posts of Postal Assistant (Circle Office / Regional Offices), Postal Assistant (Post Office) and Sorting Assistant (Railway Mail Services) from eligible officials for the vacancy year 2026 (01.01.2026 to 31.12.2026) held on 28.06.2026 followed by DEST on 02.08.2026 as per merit *vis-à-vis* order of preference exercised by the candidates subject to availability of vacancy in the Division/Unit. The result containing list of successful candidates of Category A and Category B arranged in Circle Level Merit order is enclosed as **Annexure - I**. In case of more than one candidates get clubbed due to scoring equal mark, their inter-se rank/merit has been decided in accordance with the instructions contained in Directorate Letter No. 04-08/2019-SPN-I dated 11.12.2020. Consequent to this, if any change is noticed in the merit list, the same may be communicated to this office immediately for necessary correction.

9. The LDCE result is declared on the basis of Department of Posts (Postal Assistant & Sorting Assistant) Recruitment Rules, 2022 issued by Directorate vide F. No. 04-05/2015-SPN-I dated 20.06.2022 and as amended from time to time, SOP issued vide letter no. A-34012/02/2022-DE dated 11.08.2022 and Notification issued by this office vide letter no. RE/30-23/2026(PA/SA) dated 11.05.2026.

10. Orders/guidelines relating to reservation in promotion to Persons with Benchmark Disabilities issued vide DoPT O.M. No. 36012/1/2020-Estt.(Res.-II) dated 17.05.2022, Directorate letter no. X-20/17/2024-SPN-II dated 13.08.2024 along with DoPT O.M. No. 36035/02/2017-Estt(Res) dated 27.09.2022, and other extant rules/ guidelines issued by Directorate from time to time have been complied with.

11. The selection of candidates in **Annexure-I** is purely provisional and subject to fulfillment of required conditions of relevant Recruitment Rules for promotion to the cadre of Postal Assistant/Sorting Assistant as per Directorate instruction contained vide letter no. X-7/6/2022-SPN-II dated 17.05.2023, 22.09.2023 and 04.03.2024.

12. The information relating to name of the candidates, roll numbers, designation, date of birth, date of entry, disability status and categories have been shown on the basis of information/documents furnished by the Head of Region/Division/Unit. The Divisional /Unit Heads are requested to verify the relevant particulars of the selected candidates at their own level, before issuance of promotion and posting orders. In

case, it is subsequently found that any of the selected candidate(s) was not eligible to appear in the examination under the extant rules or instructions on the subject for any other reasons or in case any mistake is found with regard to announcement of result of any candidate for any reason whatsoever, the same may be brought to the notice of Circle Office, Bhubaneswar immediately, so that his/her name could be deleted from the list of successful candidates.

13. The category of candidates may be rechecked with reference to extant rules. The selection and promotion of the candidates belonging to SC/ST/PwBD category is subject to verification of their category status by the Divisions/Units concerned as per extant instructions on the subject.

14. The candidates of reserved category i.e. SC/ST/PwBD who are shown as qualified on merit and selected against UR vacancies should be adjusted against UR vacancies in the Roster as per the guidelines issued by Department from time to time.

15. Before issuance of promotion and posting order, it should be ensured that **no disciplinary/vigilance case is pending or punishment is in force against the successful/selected/allotted candidates**. If, any such case exists, the same should be referred to Circle Office, Bhubaneswar immediately.

1 6 . **Provisional Candidates:** The Heads of the concerned Divisions/Units are requested to immediately finalize the provisional candidature and such cases should not be kept pending for long time, so that the provisional candidates may not have to wait for the result inordinately. If name of any provisionally permitted candidate is found in the list of selected candidates, the same may be brought to the notice of Circle Office, Bhubaneswar for immediate necessary action. It is informed that the names of the candidates have been arranged in the order of merit-cum-preference subject to availability of vacancy. It may also be ensured that **no provisional candidate, even if found in the list of selected candidates, shall be given promotion under any circumstances without regularization of his/her candidature**.

17. The Heads of Divisions/Units should ensure timely issuance of the promotion orders to the successful candidates of **Annexure-I** so that the selected candidates/officials can join in their respective place of posting at the earliest as per extant rules.

18. The following condition may also be incorporated in the promotion order without fail:

“In case, if it is subsequently found that any of the selected candidate(s) was not eligible to appear in the examination under the existing rules/instructions on the subject or for any reasons or in case, any error is found with regard to

announcement of result of any candidate for any reasons whatsoever, his/her name will be deleted from the selected list as the case may be."

1 9 . The Divisional/Unit Heads are requested to issue the promotion orders latest by 10.08.2026 and relieve the willing candidates immediately under intimation to this office. The candidates who are not willing to join in their promotional post be asked to communicate the same in writing immediately for onward submission to this office. Divisional /Unit Heads are further requested to intimate the joining status of the promoted candidates within seven days of issuance of this order.

2 0 . Divisional/Unit Heads are requested to submit the unwillingness / refusals (unconditional) of such selected candidates by 14.08.2026 positively so that the selection of next meritorious candidate may be done in time.

2 1 . No request for revision / change of allotment of Cadre/Division/Unit will be entertained in any circumstances.

22. The guidelines issued vide Directorate letter no. W-04/2/2020-SPN-I-Part(1) dated 19.10.2020 as well as relevant Recruitment Rules for the cadre of Postal Assistant / Sorting Assistant as amended from time to time may be followed scrupulously while issuing promotion orders.

23. The results and contents of this memo may be brought to the notice of all concerned.
