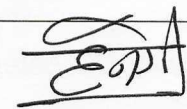
The Competent Authority is pleased to declare the results of the Limited Departmental Competitive Examination (LDCE)/ Competitive Examination (CE) for promotion/recruitment to the posts/cadre of Postal Assistant (Circle Office), Postal Assistant (Post Office) and Sorting Assistant (Railway Mail Service) from eligible officials of Category 'A', Category 'B' & GDS candidates for the vacancy year 2026 (01.01.2026 to 31.12.2026) held on 28.06.2026 and DEST held on 23.08.2026. Selection of the candidates is based on his/her performance in Paper-I (Aptitude Test). Paper-II i.e. Data Entry Skill Test (DEST) was of qualifying nature.

2. The following number of vacancies were finally approved and circulated to divisions/units vide this office letter no. Rectt./1-6/DR/PA-SA/2026 dated 03.08.2026:-

3. As per Directorate letter No.17-08/2018-SPB-I dated 10.05.2019 under Annexure-C which shall be read with letter No.17-08/2018-SPB-I (Pt) dated 10.06.2019 and No.17-08/2018-SPB-I dated 20.06.2019, 26.06.2019, 28.06.2019, 11.07.2019, 23.07.2019, letter no. 17-08/2018-SPN-I dated 09.09.2021, 17-08-2018-SPN-I (pt.) dated 21-11-2022, 29-05-2024 and letter No.17-08/2018-SPN-I dated 19.12.2022, the minimum qualifying marks as prescribed by Directorate for Paper I and II are as under:-

4. This is a promotional examination and no reservation in promotion for OBC and EWS candidates, hence, the minimum qualifying percentage of UR category will be applicable for them.

5. In pursuance to Directorate's letter No. W/04/8/2022-SPN-I date 26-10-2023 and Recruitment Rules of PA/SA, selection of candidates through examination has been done by preparing a single merit list at Circle level. The selected candidates have been allotted to the Divisions/Unit, category wise vis-à-vis order of preference exercised by the candidates and subject to availability of vacancies in the Division/Unit.

6. As per the qualifying criteria mentioned in para-3 above, only 52 Category 'A' candidates, 04 Category 'B' & 01 GDS i.e. total 57 candidates were shortlisted for Paper -II i.e. DEST held on 23-08-2026.

7. As per Directorate's letter no. 17-08/2018-SPN-I dated 19-12-2022, the number of candidates to be shortlisted for DEST shall be kept as three time of the number of vacancies notified.

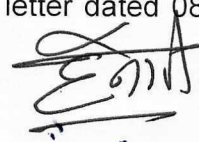
8. The results containing list of successful candidates of Category 'A' and Category 'B' & GDS (arranged in Circle-wise merit order) is mentioned in Annexure - I. The inter se Rank/ merit of candidates have been decided as per Directorate's letter No. 04-08/2009-SPN-I dated 11-12-2020. Consequent to this, if there is any change in merit list, the same may be communicated to this office for issuing correction.

9. The Candidates have been allotted to the extent of vacancies notified for vacancy year 2026 except 03 vacancies of ST Category of PA(PO) cadre and 01 vacancy of UR/PH (VH category) of PA (CO) cadre remained unfilled due to non-availability of qualified candidates of ST category and UR/PH (VH category) respectively.

10. 01 unfilled UR/PH (HH category) vacancy of the PA(PO) cadre for vacancy year 2025 has been exchanged with the available qualified candidate of (OH category). The HH category vacancy may be identified to respective category in the vacancy year 2027.

11. 01 UR/PH (Others) category vacancy of PA (PO) cadre for vacancy year 2025 has been filled up by the UR category candidate due to non-availability of qualified PwBD candidate in accordance with para 7 of Directorate letter No. X-20/17/2024-SPN-II dated 08-07-2025 and reservation (UR/HH) is to be carried forward for the next vacancy year i.e. 2027.

12. 01 unfilled UR/PH (OH category) vacancy of SA cadre for the year 2024 could not be exchanged due to non availability of suitable UR (OH) category candidate and filled with UR category candidate in accordance with para 7 of ibid letter dated 08-



07-2025 and reservation (OH category) will be carried forward for next recruitment year i.e. 2027 and thereafter it shall lapse.

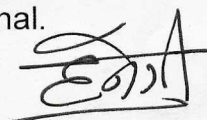
13. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Divisions/Units. In case there are any mistakes in the details of candidate (s), the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidate (s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates as the case may be.

14. In accordance to Directorate's letter no. W-17/10/2023-SPN-I-DOP dated 06-03-2023, the candidates who were declared successful through LDCE for promotion to PA/SA cadre and had declined their promotion for vacancy 2024 and have again been declared successful through LDCE for promotion to PA/SA cadre for vacancy year 2026 should be promoted only after completion of their embargo period.

15. The selection of candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Division/Unit is requested to verify the current status of the candidature of the qualified candidates before promoting. The candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be promoted and such cases should be referred back to this office as per Directorate's letter no. X-7/6/2022-SPN-II dated 17-05-2023, dated 22.09.2023 and dated 04.03.2024.

16. Since the examination has been conducted using OMR answer sheets, the request for re-totalling /re-evaluation will not be entertained. Photo copies of answer papers will be supplied to the candidates on submission of application under RTI Act 2005. Applications other than under RTI Act, 2005 for supply of photo copies will not be entertained.

- (i) The period of preservation of OMR answer sheet is one year from the date of declaration of **Main Result**. Therefore, applications received after one year for supply of photo copies of answer sheet will not be entertained by the department.
- (ii) Candidates who wish to have the copies of OMR answer sheets supplied are required to pay a fee of Rs. 25/- per paper plus Rs. 10/- towards fee for application under RTI Act, 2005 in the post office and submit their applications to CPIO/ APMG (S & R) O/o Chief Postmaster General, Uttarakhand Circle, Dehradun - 248001 through their respective Division/ Unit (Through proper channel only) along with the receipt of payment of fee in original.



- (iii) Photocopies of OMR answer sheet will be supplied only to the candidates who appeared for the examination. Therefore, the candidate should invariably intimate their Roll No. in the application under RTI Act.

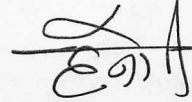
17. The provision of reviewing of results of failed SC/ST candidates has been revisited by the Postal Service Board and decided to discontinue, as communicated vide Postal Directorate's letter No.- 4-13/2015-SPN-I dated 08-04-2016.

18. The Divisional/Unit Heads will issue offer of promotion by 31.08.2026 and the successful candidates may be directed to accept/decline their offer within 5 days from issuing offer of promotion order, failing which their promotion will be deemed to have been declined.

19. The Divisional Heads of selected candidates are instructed to take necessary action for joining of newly selected candidates as per extant provisions.

20. All Divisional Heads may also ensure that SC/ST certificates of the officials being selected against SC/ST vacancies are verified from the concerned sources as per extant rules and if any discrepancy is found, it should be promptly intimated to this office.
