Subject: Limited Departmental Competitive Examination (LDCE)/Competitive Examination for promotion/recruitment to the posts of PA/SA for the vacancy year 2026 held on 28.06.2026 followed by DEST on 16.08.2026 - Declaration of final result.

Reference is invited to this office letter no. Rectt/R-2/LGO Exam/2026/KW5 dated 04.08.2026 whereby the list of candidates shortlisted (03 times of vacancies) on the basis of marks of Paper-I was published. The Data Entry Skill Test (DEST) of candidates shortlisted in Paper-I was held on 16.08.2026. The Competent Authority has directed the undersigned to declare the final result of aforesaid examination(s). The result of meritorious selected candidates along with marks and allotted Division/Unit is enclosed as **Annexure-I**.

2. Further, in accordance with the Department of Posts (Postal Assistant & Sorting Assistant) Recruitment Rules, 2022, notified vide G.S.R. 459(E) dated 17.06.2022, as amended vide G.S.R. 21(E) dated 13.01.2023 and G.S.R. 470(E) dated 01.08.2024, Directorate letter No. 04-05/2015-SPN-I dated 20.06.2022 and letter no. X-12/6/2021-SPN-II dated 31.12.2021, a single merit list at Circle level has been prepared for filling up of 86 notified vacancies. The selected candidates have been allotted to the Divisions/Units in accordance with merit, category-wise, i.e. UR, SC and ST, vis-à-vis the order of preference exercised by the candidates, subject to availability of vacancies in the respective Divisions/Units.

3. Since, Limited Departmental Competitive Examination is meant for filling up of vacancies under departmental promotion quota, no reservation for OBC, EWS categories is applicable as per the extant rules/guidelines on the subject.

No vacancy remained unfilled for Competitive Examination for recruitment to the posts of PA/SA from eligible GDSs for the vacancy year 2026.

4. In cases where more than one candidate has secured equal marks, the inter-se rank/merit has been determined in accordance with the instructions contained in Directorate's letter no. 04-08/2019-SPN-I dated 11.12.2020. Accordingly, the inter-se rank/merit has been determined for all categories.

The Heads of Divisions/Units are requested to re-check the service particulars of the successful candidates before issuing the offer of appointment/promotion order. In case any discrepancy is noticed, the same may be corrected and reported to this office. The Divisions/Units shall also ensure that the number of candidates allotted to them does not exceed the number of vacancies proposed to be filled through the said examination(s).

7. In case it is subsequently found that any selected candidate was not eligible to appear in the examination under the existing Rules/Instructions on the subject, or if any discrepancy is found in the merit list for any reason whatsoever, his/her candidature will be treated as cancelled.

8. The offer of appointment/promotion order shall be issued by the concerned Heads of Divisions/Units to the selected candidates by **09.09.2026**, with clear directions to either accept or refuse the offer of promotion by **18.09.2026**.

It may be ensured that no candidate, whose punishment period is still in force, is appointed before the expiry of the punishment period.

9. In respect of **SC/ST/PwBD Candidates**, promotion/appointment shall be provisional, subject to verification of their caste/PwBD certificates. The Head of the Division/Unit shall obtain an undertaking from such officials to this effect at the time of their joining and shall ensure verification of their caste/PwBD status within one month.

10. Requests for revaluation shall not be entertained in view of the instructions of the Directorate.

11. The Competent Authority reserves the right to make any change(s) in the merit list of selected candidates for any reason, in accordance with the existing Rules and Instructions on the subject.

12. The detailed marks/result of all candidates who appeared in the examination(s) will be released shortly.
